- Encourage more efficient use of water, reduce soil erosion, promote clean water, encourage conservation of indigenous or valued plants and animals, save energy or achieve better pest control
- Conserve or enhance existing native vegetation
- Support the matters listed above through education, creating networks, or raising awareness

The award promotes and celebrates sustainable management and enhancement of environmental resources through the following characteristics:

- Promoting awareness of the importance of maintaining our environmental resources for future generations
- Recognising and rewarding activities that show sustainable management
 - Encouraging efforts that are managing and caring for resources in a better way

The nominee must give their permission to be nominated by signing the form on **page four** or by expressing their permission via email/attached letter.
