BOUNDARY

The Fencing Act 1978 clearly sets out the rights and responsibilities relating to fences between neighbouring properties.

Generally, if you want to build a fence on a common boundary, or upgrade an inadequate existing fence, you and the owner of the neighbouring property must go halves in the cost.

A fence might be needed to serve several purposes:

- For privacy
- For protection from weather conditions

- For keeping animals in of a subdivision which need
- For an aesthetic backdrop

Ideally, you can work together with your neighbour and agree on what is best for both parties. However, you may not have the same ideas as your neighbour or the money to spend on the fence and this is how disputes can

The height of the fence cannot be higher than two metres unless you get a building consent and resource consent from your local council. Also, there on the title by the developer org.nz or www.dbh.govt.nz

to be addressed before commencing any fencing.

The fence should be placed on the boundary line. If it is going to go more on one side than the other, this needs to be agreed by owner of that side, but if an agreement cannot be reached, you can't just go ahead and put up a fence on the boundary line. There is a process to follow and you must 'serve a notice' on your neighbour giving the details of your proposal in writing.

CENTRAL PLAINS WATER ENHANCEMENT SCHEME

The Selwyn District Council has received the decision by Central Plains Water Ltd on the recommendation made by independent commissioners appointed by the Council regarding the notice of requirement for the Central Plains Water **Enhancement Scheme.**

The decision by Central Plains Water Ltd was to:

- accept the independent commissioners recommendation that the requirement for a designation be confirmed; and
- accept, in substantial part, the independent commissioners recommended conditions with

modifications to Conditions 14 and 15.

The recommendation made by the independent commissioners to Central Plains Water Ltd dated 28 May 2010, the Central Plains Water Ltd decision dated 13 July 2010, a tracked changes version of the conditions for the notice of requirement incorporating the decision by Central Plains Water Ltd and a map identifying the location of the notice of requirement can be viewed

Any person who made a submission on the notice of requirement may appeal the decision by Central Plains Water Ltd to the Environment Court. Appeals must be in the prescribed form (Form 22) in the Resource Management (Forms, Fees and Procedure) Regulations 2003 or similar format and must be lodged with the Environment Court within 15 working days of receipt of the notice of the decision by Central Plains Water Ltd.

RESOURCE CONSENTS

Because of their possible environmental effects, many activities need resource consent from the Council. You have the right to inspect the following consent application at any Council Service Centre during normal office hours and to make a submission supporting or opposing it.

Maluern Ward

State Highway 73 - west of Darfield

Fonterra Co-operative Ltd (Application 105211) seeks a ten-year consent to construct, operate and maintain a milk powder plant with associated ancillary activities 3.5 km west of Darfield. The plant will operate up to 24 hours per day and seven days per week.

The application includes the employment of approximately 50 staff, a building site covering approximately 12 hectares, a building height of up to 52.25 metres and a stack height of up to 60.1 metres, approximately 60,000 cubic metres of earthworks to level the site, the creation of noise bunds and a storage pond, the establishment of a rail siding into the site, a total of 52.5 square metres of signage in three signs, the storage of hazardous substances, the generation of solid waste and vehicle movement generation, all exceeding the permitted levels.

The building site is located between State Highway 73 (West Coast Road)/Midland Railway line, Auchenflower and Loes Roads. The site itself is described as Lot 1 DP (Deposited Plan) 68528, Lots 2 and 3 DP 63630, Lots 1 and 2 DP 78173, Lots 2 and 4 DP 20115, Lot 2 DP 77605, Lot 3 DP 60325, Lot 1 DP 367426, Lot 1 DP 67185, Lot 2 DP 304774, Lot 1 DP 8545 and Lots 1 and 2 DP 11000.

- your name, postal address, phone or fax
- the applicants' name, number and location
- whether you support or oppose the application
- your reasons
- the decision you wish us to make
- whether you wish to speak at a hearing
