Selwyn District Resource Management Planner Andrew Mactier says that less than one percent of the

"The Canterbury Plains is listed as an acutely threatened natural environment which makes the remaining native biodiversity in Selwyn District rare and important.'

Around \$40,000 is available in the fund to help protect and restore areas of native vegetation on private land. Priority is given to supporting work on sites which have been identified and confirmed as having significant ecological values through a formal ecological assessment. A second priority is supporting sites which may have lower value remnant vegetation but which would benefit from works and management.

Over \$200,000 has been allocated to over 60 projects through the fund since 2006. Funding has been used for a wide range of projects in previous years including work to restore existing native vegetation by landowners, schools and community groups, and establish new native plantings. The fund has also been used to help fund a field survey of threatened beetles in the Selwyn District and to conduct an environmental perceptions survey. Fire Restrictions Ease

A restricted fire season is now in force across • Fires inside properly constructed drums are Selwyn district, and replaces the prohibited fire season previously in place.

Under a restricted fire season, only gas barbeques, crop residue and rubbish fires inside contained drums are allowed. Specific conditions must be met before these types of fires can be lit.

With fire restrictions being changed, Mr Brown says that it will become more common for people to see crop residue fires burning. "It's expensive to attend false call outs so we encourage people to consider whether a fire is an emergency before they dial 111. If there are people on site supervising the fire, a fire break and water on hand it is probably a controlled operation – however if there is no one present people should report this by dialing 111."

What's allowed in a restricted fire season:


Gas barbeques are allowed if a water source is nearby.

- allowed. Only vegetation, paper, cardboard and untreated wood can be burned and the fire must be during daylight hours and attended at all times. A water source must be nearby to extinguish the fire if needed and the fire may not be lit when strong winds are blowing or forecast.
- The burning of crop residue is allowed but only during daylight hours and must be attended at all times. Fires may not be lit when strong winds are blowing or forecast, firefighting equipment must be nearby and a 10 metre firebreak must be cleared around the edge of the area to be burnt.
- Fire may be lit if a specific permit has been issued by Selwyn District Council and the conditions of the permit are followed.

What's not allowed:

Any type of fire not listed as allowed above.

Drive Safe this Easter

Most people have already planned their well-earned break for Easter Weekend. As usual, it is expected that traffic volumes will start to increase from about Thursday and remain high until Tuesday next week.

Sadly, the greater volumes of traffic often result in increased road crashes. New Zealand wide, during the last three Easter weekends, there were 401 injury crashes recorded. These crashes resulted in 17 fatalities, 107 people receiving serious injuries and 464 received minor injuries.

Over Easter weekend, there will be more camper-vans, vehicles towing trailers, caravans or boats on our roads. It is essential to allow more time to get to your destination, drive with patience, and avoid taking unnecessary risks. Driving tired (fatigue) contributed in many of these crashes.

Always plan your journey to include drive time and rest breaks and drive at times when you are normally awake. Also, if you recognise the early signs of fatigue either in yourself or your driver and take action, then the risk of a crash is greatly reduced. A few simple driving tips are:

- rest before you drive
- take regular breaks
- · share the driving

Temporary Libraries Closure

The Darfield, Leeston, Lincoln and Rolleston library/service centres will be closed on Tuesday 9 and Wednesday 10 April to enable a new IT system to be installed. Our mobile library will also not be operating on these days. However, the Council's main office in Rolleston and the Rolleston Community Centre will be open on these days.

The new IT system will allow us to be able to purchase and loan e-books. It will also have an improved search function and other benefits to library users.

While our libraries are temporarily closed on these two days, you can still:

- use the library website (www.selwynlibrary. co.nz) to access our online databases from home, but you won't be able to use the library catalogue or visit our libraries in
- return items through the after-hours slot Return dates for books and other items have all been automatically extended, so no items will be due back when the closure occurs.

Restricted Fire Season Replaces Prohibited Fire Season

Notice is hereby given that as from Friday 22 March the previously advertised Prohibited Fire Season is now replaced by a Restricted **Fire Season** for the whole of Selwyn District.

Notice is hereby given that pursuant to Section 22(2) of the Forest & Rural Fires Act (1977), the lighting of fires in the open air within the rural areas of Selwyn District is restricted from Friday 22 March 2013 until further notice.

The exemptions to this are:

- 1. The burning of crop residue will be permitted without the issue of a Fire Permit providing the following conditions
 - Fires shall only be lit during daylight hours and must be out by
 - No fires shall be lit while strong winds are blowing or forecasted, or when conditions are such that the fire is likely to spread beyond the limits of the land for which this Authority is issued. Maximum allowable wind strength is 19kph (Beaufort Scale 3).
 - The area to be burnt is to be surrounded by a continuous fire break, cleared of all combustible material to a minimum width
 - The fire is to be patrolled by the person lighting the fire until it is completely out.
 - Prior to lighting, the occupiers of neighbouring properties are to be advised of the time and date of burning.
 - That some form of Fire Fighting Equipment, such as grubbers, beaters, fire extinguishers or vehicle mounted water supply/ spray units, is on site to deal with any fire outbreaks.
- 2. Fires are permitted in enclosed drums providing the following conditions are met:
 - The drum top must be covered with a wire mesh sized no greater than 20mm, or have a lid and flue with a spark arrester fitted.
 - The drum must be surrounded by a 3 metre area that is cleared of combustible material and be at least 3 metres away from other buildings, trees or vegetation.
 - The area must be serviced by a reticulated water supply or an alternative water supply (tanker, dam, etc). The water supply must be capable of fully extinguishing the drum fire and the area immediately around it.
 - The drum fire must only be lit during daylight hours and fully extinguished by dark.
 - The drum fire must be attended by someone at all times until it is completely out.
 - The drum fire must not be lit when the wind is blowing or forecasted to be above 19kph (Beaufort Scale 3).
 - The drum fire must not be lit or allowed to burn when the smoke is likely to cause nuisance to neighbours.
 - Only vegetation, paper, cardboard and untreated wood are allowed to be burnt under Environment Canterbury Air Plan.
- 3. Gas fuelled barbecues lit in properly constructed containers.
- 4. Only gas fuelled barbecues lit in properly constructed containers are permitted in Council Reserves.
- Burning may be permitted if a Fire Permit has been obtained from the Principal Rural Fire Officer.

- 1. These exemptions apply to the Rural Areas of Selwyn District only. No open air fires may be lit within residential areas without a Resource Consent from Environment Canterbury.
- 2. Any Permit used is not a Legal Defence against a claim for any damage which may be caused by the fire. The responsibility for its control and the liability for any damage which may arise lies with the person lighting the fire.
