- a programme of services and activities to help achieve the outcomes
- the performance targets for the services and activities
- how much we estimate the services and activities will cost
- how much we estimate ratepayers will need to pay.

Please have a read and if you have any comments to make on the proposals, or ideas about better ways of achieving the community outcomes, write them down and send them to us. Written submissions on the draft Plan can be made from Tuesday 2 April until 5pm on Friday 3 May 2013.

Hearings will be held on 17 and 20 May. Please say in your submission whether or not you wish to come to a hearing and talk to the councillors about your submission. Following the hearings, the Council will discuss the ideas submitted and then make its final changes to the budget, which will then be adopted and become operational on 1 July 2013.

Council officers will be attending some local committee meetings to talk about the draft Plan.

The first meeting will be held at Doyleston on Wednesday, 10 April at 7.30pm at Osborne Park Hall. Details of other meetings will be notified in Council Call.

### Proposed amendments to the Council's Long Term Plan 2012/22

The Council is proposing to amend its Long Term Plan 2012/22 to allow the liquidation of Selwyn Investment Holdings Limited.

Copies of the proposed amendment and summary are included in the draft Annual Plan available from our service centres, libraries, and on our website [selwyn.govt.nz](http://selwyn.govt.nz).

Please have a read and if you have any comments to make on the proposed amendment write them down and send them to us.

Written submissions must reach us by 5pm on Friday 3 May 2013.

Hearings will be held on 17 and 20 May. Please say in your submission whether or not you wish to come to a hearing and talk to the councillors about your submission.

Following the hearings, the Council will discuss the submissions and then make its final decision on the amendment to the Long Term Plan, which will then be adopted and become operational.

## Temporary Libraries Closure

The Darfield, Leeston, Lincoln and Rolleston library/service centres will be closed on **Tuesday 9** and **Wednesday 10 April** to enable a new IT system to be installed. Our mobile library will also not be operating on these days. However, the Council's main office in Rolleston and the Rolleston Community Centre will be open on these days.

The new IT system will allow us to be able to purchase and loan e-books. It will also have an improved search function and other benefits to library users.

While our libraries are temporarily closed on these two days, you can still:

- use the library website ([www.selwynlibrary.co.nz](http://www.selwynlibrary.co.nz)) to access our online databases from home, but you won't be able to use the library catalogue or visit our libraries in person
- return items through the after-hours slot

Land Use Recovery Plan Consultation

Environment Canterbury is consulting on a draft Land Use Recovery Plan for greater Christchurch. The Plan covers the townships of Rolleston, Lincoln and West Melton and areas of Selwyn near to Christchurch City.

The Recovery Plan recommends 46 responses that will help support recovery and rebuilding within the Greater Christchurch area over the next 15 years. For example, identifying priority areas for residential and business growth, review regional and district plans to help streamline processes for recovery purposes and providing for a diverse range of housing types.

In addition, specific responses have been identified for the Selwyn District Plan. These include,

- Rezoning 72 hectares of land within Prebbleton
- Removal of infrastructure staging requirements in Living Z zones in Rolleston and Lincoln
- Amending rules relating to Medium Density housing, fencing and section sizes in Living Z zones
- Develop three Outline Development Plans within Rolleston.

If these changes are adopted by the Government through the Land Use Recovery Plan, the Council would be directed to adopt these changes as part of its District Plan. The changes may not go through any further notification or appeal process.

A workshop on the plan is being held on Monday 8 April from 6 – 9pm at the Lincoln Event Centre, Meijer Drive, Lincoln, and a series of workshops are being held in Christchurch. Written comments on the plan close on Monday 22 April.
