Restricted Fire Season

on Wednesday 5 November 2014 a Restricted Fire Season applies across the whole of Selwyn

Notice is hereby given that pursuant to Section 22(2) of the Forest & Rural Fires Act (1977), the lighting of fires in the open air within the rural areas of Selwyn District is restricted from 12 noon on Wednesday 5 November 2014 until further notice.

The exemptions to this are:

- 1. The burning of crop residue will be permitted without the issue of a Fire Permit providing the following conditions
- Fires shall only be lit during daylight hours and must be out by dark.
- No fires shall be lit while strong winds are blowing or forecasted, or when conditions are such that the fire is likely to spread beyond the limits of the land for which this Authority is issued. Maximum allowable wind strength is 19kph (Beaufort Scale 3).
- The area to be burnt is to be surrounded by a continuous fire break, cleared of all combustible material to a minimum width of 10 metres.
- The fire is to be patrolled by the person lighting the fire until it is completely out.
- Prior to lighting, the occupiers of neighbouring properties are to be advised of the time and date of burning.
- That some form of Fire Fighting Equipment such as grubbers, beaters, fire extinguishers or vehicle mounted water supply/spray units is on site to deal with any fire outbreaks.
- 2. Fires are permitted in enclosed drums providing the following conditions are
- The drum top must be covered with a wire mesh sized no greater than 20mm or have a lid and flue with a spark arrester fitted.
- The drum must be surrounded by a 3 metre

area that is cleared of combustible material and be at least 3 metres away from other buildings, trees or vegetation.

The area must be serviced by a reticulated

- water supply or an alternative water supply (tanker, dam, etc). The water supply must be capable of fully extinguishing the drum fire and the area immediately around it.
- The drum fire must only be lit during daylight hours and fully extinguished by dark.
- The drum fire must be attended by someone at all times until it is completely out.
- The drum fire must not be lit when the wind is blowing or forecasted to be above 19kph (Beaufort Scale 3).
- The drum fire must not be lit or allowed to burn when the smoke is likely to cause nuisance to neighbours.
- Only vegetation, paper, cardboard and untreated wood are allowed to be burnt under Environment Canterbury Air Plan.
- 3. Gas fuelled barbecues lit in properly constructed containers.
- 4. Only gas fuelled barbecues lit in properly constructed containers are permitted in **Council Reserves.**
- 5. Burning may be permitted if a Fire Permit has been obtained from the Principal **Rural Fire Officer.**

Notes

- 1. These exemptions apply to the Rural Areas of Selwyn District only. No open air fires may be lit within residential areas without a Resource Consent from Environment Canterbury.
- 2. Any Permit used is not a Legal Defence against a claim for any damage which may be caused by the fire. The responsibility for its control and the liability for any damage which may arise lies with the person lighting the fire.

RESOURCE MANAGEMENT ACT 1991

Because of their possible environmental effects, many activities need a resource consent from the Council.

You have the right to inspect the full consent application received by council at any Council Service Centre during normal office hours or view on the council website www.selwyn. govt.nz and make a submission supporting or opposing the proposal.

Any person may make a submission but a person, who is a trade competitor of the applicant, may do so only if that person is directly affected by an effect of the activity to which the application relates that

- (a) adversely affects the environment, and
- (b) does not relate to trade competition or the effects of trade competition.

Selwyn Central Ward

Applicant: Road Metals Company Ltd (Attn Jonny Francis) PO Box 2341, Christchurch 8140.

Site of Application: A block of approximately 284 hectares bounded by Wards, Sandy Knolls and Kerrs Roads, Burnham on RS 31530, Pt RS 32004 and lots 4 & 6 DP 440446.

Application: 145436 –A variation to RC 105334, consent to establish and operate a quarry on RS 31530 & Pt RS 32004. This variation seeks to increase the extraction of aggregate from 160,000m³ per year to 500,000m³ per year, to increase the hours of operation, and to increase heavy vehicle movements from a maximum of 200 per day to a rolling average of 500 per day.

How to make a submission:

If you wish to support or oppose a consent application you must get a written or electronic submission on Form 13 or to the like effect into any Council Service Centre by the closing date 5pm Thursday 4 December 2014, and promptly send a copy to the applicant's service address. Controlling Rubbish at | **Subdivision Sites**

If you are involved in work on a construction site, please be aware that you are responsible for picking up any rubbish that occurs as a result of construction. During the springtime, strong Northwest winds often occur, and you will need to tie down and cover skips to prevent rubbish being blown to neighbouring properties.

You should check the site and remove any loose pieces of plastic that could fly away. Dust can also be a problem when dry weather is combined with strong winds, and you may need to dampen down soil. Your resource consent may also list specific actions you need to take on site.

Council's Environmental Health staff have been making site visits and speaking to building contractors about this issue to check that they are keeping sites as tidy as possible and picking up any rubbish that has spread elsewhere. These visits are being undertaken to help prevent activities at building sites affecting neighbouring properties. Environmental Health officers can be contacted by phoning 03 365 1667 for advice or to register complaints.



Guy Fawkes Night 2014

The New Zealand Fire Service has the following safety advice for anyone planning to use fireworks:

- ★ Read and follow instructions on fireworks before using them. Read instructions with a torch (not a naked flame)
- ★ Light fireworks in a wide open area away from anything that could catch fire
- ★ Fireworks, alcohol and drugs are a dangerous combination
- Never let a child light fireworks
- ★ Keep a bucket of water or a hose handy
- ★ Keep unlit fireworks in the bag until you are ready to use them
- ★ If one of your fireworks doesn't go throw it away. Don't attempt to reignite it
- ★ Burns should be run under cold running water for at least 20 minutes
- ★ Fireworks are noisy so please be considerate of your neighbours. Keep pets inside as they may be frightened
