

A space for all the community is starting to take shape in the new Rolleston town centre.

Nine colourful poles decorated by schools from around Rolleston have been installed in the sensory space next door to Te Ara  $\bar{\text{A}}$ tea.

Nine schools have been involved in creating the feature poles and decorative tiles for the sensory space. The poles feature a range of themes from representing unique school character to the region's landscape, flora, birdlife, and environment.

Waitaha School has also created mosaic tiles for a tree ring mosaic, which has been put together by Springston artist Raewyn Beaver of MACS Mosaics. The mosaic will be installed on site in the coming weeks.

The sensory experience, designed to cater for people's different neurological and physical needs, is being built by Armitage Williams, and is intended to be open by the end of the year, around the same time as Te Ara Ātea.

Surrounded by raised gardens and trees, the experience will be a highly accessible space with a treat for all the senses, from a quiet space, to areas with bursts of colour, musical instruments, different tactile experiences, smells and even tastes from edible plants.

Council Acting Major Projects Property Manager Phil Millar says it's an exciting step to see the posts and mosaics going in on site.

"The sensory space is a real community project and it's really cool to see these colourful and really thoughtful pieces going in. All the artists involved have put their heart into it and created something really special that will be a long-lasting source of joy for everyone using the space."

# Selwyn Libraries launches free online click and collect service

Selwyn Libraries has launched a new collection service to keep avid readers busy even at COVID-19 Alert Level 3.

The Click and Collect service enables library members to request quality items personally selected by the Selwyn Libraries team.

It's easy to use – just fill out a short form online to identify your areas of interest. The Selwyn Libraries team then build a pack of five items from the stock available at your local library of choice. There is no charge for this service.

Once the team have selected your items, you'll be contacted by phone or email to arrange a suitable collection time. They'll give you the instructions for how to collect your items.

Collection is contactless and in accordance with COVID-19 social distancing protocols.

The service covers popular catalogue items including adult fiction, magazines, children's books and jigsaw puzzles.

# Consultation open on local representation

Consultation is now open on a proposal for future local representation for Selwyn.

The proposal will result in changes to the way the Council is elected and structured from the next local elections in 2022.

The Council is proposing to keep four wards, but with changes to ward boundaries, and a reduction in the number of councillors from 11 to 10. It also proposes to retain the Malvern Community Board.

Councils must review their representation arrangements at least every six years.

Since its last representation review in 2015, Selwyn's population has grown rapidly but the ratio of population per councillor has become uneven.

"One of the key principles of fair representation is that each elected member should represent roughly the same number of people," says Mayor Sam Broughton.

"This proposal will help to ensure a more equal distribution of councillors, so that residents get fair and equal representation around the Council table."

The key changes include:

- · West Melton would move to the Malvern Ward
- · The area between Burnham and Rolleston would move to the Ellesmere Ward
- · An area east of Rolleston would move to the Springs Ward.

The Selwyn Central ward would be replaced by a smaller Rolleston ward with three councillors rather than the existing four. All the other wards would keep their existing number of councillors. The total number of councillors would reduce from 11 to 10.

The Malvern Community Board would be retained, with five members. The existing subdivisions of Hawkins and Tawera would be retained, and a third subdivision added, covering West Melton.

Submissions on the proposal are open until 5pm, Monday 4 October. Submission forms, maps and more information are available online at selwyn.govt.nz/representation.

Mayor Broughton says the Council is hoping to hold drop-in information sessions later this month, depending on COVID-19 alert level requirements.

"We're also planning some online information sessions, so we encourage people to check the website for the latest updates and any changes.

"We do want to hear people's views. It's important we get this representation structure right – so residents can be confident that they are well represented, and that the Council can function effectively."

# Dog registration extended

The Council is moving to support dog owners as the lockdown has caused delays with processing registrations.

Due to COVID-19 restrictions at Alert Levels 3 and 4, the Council's Animal Control team has not been able to process all of the received dog registrations.

In response to this the registration period for the final dogs to be registered has been extended to 30 September.

"At the moment we have a backlog of around 1,500 dog registrations which we will be able to work through once we are under COVID-19 Alert Level 2 and we are able to get back into our offices. At this stage we expect that there will be around a fourweek delay to get all due dog tags out," Animal Control team leader Steve Clarke says.

'We would like to reassure owners that if you have paid your dog's registration fee, we can see your transaction, so we won't be issuing any fines for your dog not being registered.'

Mr Clarke says owners who have not yet received their new One Tag should keep on their blue 2020 registration tag until the new One Tag has arrived.

The infringement fee of \$300 for any unregistered dogs may now be issued by the Council after September. More information can be found on Council website at www.selwyn.govt.nz/dogregistration.

### **Animal Control**

We will continue to respond to animal control requests and incidents.

The dog pound will continue to operate.

Issuing of new dog registration tags is on hold at present and will resume as soon as practicably possible.

### **Building Consents**

We will continue to process new consent application and existing applications already in the system. This service may be subject to some limitations due to restricted access to physical property files.

### **Building Inspections**

Building inspection bookings have resumed.

Inspections from 20 August to 30 September have been cancelled and will need to be rebooked to ensure customers can meet the safety requirements for Alert Levels 3 and 2. Customers can rebook a cancelled date if they are still able to be ready on that date. Please help us catch up by only booking an inspection time if you can be ready by 7.30am on the inspection date.
