

The Council is preparing changes to its housing intensification rules in the Proposed Selwyn District Plan, with public consultation expected in August this year.

New building intensification rules recently introduced by Government require all Tier 1 Councils including Selwyn - to prepare and notify a variation to their district plans by 20 August 2022. The variation must include new rules and policies that enable medium density and intensification in relevant residential zones, Council's Planning Manager Ben Rhodes says.

The variation will cover:

- · the introduction of a new Medium Density Residential Zone that will be applied to relevant residential zones in Rolleston, Lincoln and Prebbleton
- · additional land for residential development in Rolleston, including certain private plan change requests currently being processed by the Council.

The government rules require councils to vary private plan changes that were notified before the new legislation come into effect (20 December 2021). These will be notified at the same time as the variation to the proposed plan, Mr Rhodes says.

Based on legal advice and information available to date, each private plan change request will be affected differently.

Once a draft of the variation is developed, it will go to the Council for approval and then be notified for public consultation. Public consultation will begin by 20 August 2022 at the latest.

"To enable the variation process to be completed, including the new hearings, there will be a delay on when the Proposed Plan becomes operative, as well as the affected private plan changes", says Mr Rhodes

The Proposed District Plan was notified at the end of 2020 and was expected to become operative at the end of 2022. With the variation it is now expected that the Proposed District Plan will become operative in early 2024.

It's important to note, no appeals will be possible on decisions relating to matters covered by the variation. This follows the new legislation that introduces a new planning process which Tier 1 councils must use to implement intensification policies more quickly.

Building consents increasing

A slowdown in applications and hard work from the Council consents team has seen the average number of working days to process an application falling.

At the end of February the average number of working days to process an application was 22 days.

However, with numbers increasing again and March traditionally seeing high numbers of applications the Council is reminding applicants:

- \cdot Expect to see and plan for delays we are likely to see timeframes extend out again
- · Make sure your application meet our criteria
- · Remember to use the professional partnership programme (PPP) partner if you're an approved partner.

The increase in applications will put our consent team under further pressure, so we need your help to manage the workload and we will be taking a firmer approach as well.

Applications not meeting the criteria on our website, or which are for a subdivision that doesn't have s223, will not be accepted. You can find the criteria at Selwyn.govt.nz/building in the information required section under 'applying for approvals'.

Consents can be fast-tracked for applications under our PPP. This programme is for approved designers and agents with applications that meet specific criteria.

Our PPP has had a slow uptake since we launched in in May 2021 and we are encouraging more designers and companies to embrace this fast track option. If you want to find out more visit our website on how to become a partner and help get your consents fast-tracked.

Another chance on offer to blaze a trail into work

Another chance to be a trailblazer is on offer with the Council looking for more young people to support into work.

Applications are now open for the fourth round of the Council's Trailblazers internship programme, a collaboration by the Council and Youth Pathways, with support from the Ministry of Social Development, that is helping people who are unemployed or working less than 30 hours a week gain work skills.

The internship programme aimed at young people aged 18-24 began in October and has already seen half of the interns gain jobs.

Over six weeks, up to 10 interns are able to try out different jobs within the Council and gain practical experience in their areas of interest. They also receive mentoring and support from Youth Pathways coordinators who tailor the course to support members in becoming work ready and on areas such as mental and cultural wellbeing and learning their strengths.

Interns try out roles such as Duty Manager, Event Manager, Recreation Assistant, Library/Customer Service Assistant and Programme Coordinator, and complete an additional 20 hours of practical experience in their area of interest.

One member gained a job during the current intake after being supported to apply by mentors on the course and helped with job interview techniques and practice questions.

Leeston Cycle Club racing ahead with community funding

Council support has helped keep the Leeston Cycle Club racing ahead.

The club runs its annual racing season from September to March with weekly races every Thursday evening around the Leeston area.

New road rules introduced by Waka Kotahi in 2021 to improve safety meant the club was facing a hefty bill of over \$3000 to provide the signage required to race, Club President Mark Booth says.

The club was able to borrow signage from the Pegasus cycle club last year, but that wasn't a long-term option.

Fortunately, the Council was able to help with a grant of \$3283 from the Council's Selwyn Community Fund helping it buy the signage needed to keep the races going.

"That money for the signs was just beautiful. We couldn't have asked for better."

The fund was created to support Selwyn groups and organisations that contribute to community wellbeing, aiming to increase opportunities for physical activity, participation and community as well as drawing people to Selwyn.

Leeston Cycle club fitted the brief well. Its philosophy of creating a family friendly environment to support people into keeping fit and active and having has seen membership rise by 50% this year.

The club's Thursday evening races include social, youth and development rides along with opportunities for the more competitive.

It also provides opportunities for volunteers and cyclists draws from all over including many who cycle from Christchurch to take part in the races

Having the signs will allow the club to continue running the races for years to come, Mr Booth says.

"It helped us immensely. We can use them every year, so we're really appreciative."

Selwyn District Council resolved to accept the Commissioner's recommendation to approve GW Wilfield Ltd's request to rezone approximately 33ha of Rural Inner Plains land in West Melton to Living West Melton (WM South) zone and to insert a new Outline Development Plan to guide the development. The location to which this request relates is land on the southern side of West Melton along Weedons Ross Road.

This Council decision has legal effect from the day of the public notice (9 March 2022) and the Operative Selwyn District Plan is deemed amended in accordance with this decision.

On the Roads

Tennyson Street Rolleston Drive Intersection Upgrade

Tennyson Street is closed from south of 75 Tennyson Street (the Police Station) to 78 Tennyson Street and Rolleston Drive is one-way westbound for the upgrade of the Tennyson Street and Rolleston Drive intersection. Detours are in place.

Darfield Kirwee Wastewater Pipeline project

Burnham Road is closed to northbound traffic north of the Burnham School Road intersection to State Highway 1 from 10 January to 26 April. A detour will be in place.

Aylesbury Road between SH1 and Two Chain Road is reduced to one-way only. Traffic will be able to enter from SH1 and move north past the one-way site. The one-way system will be in place until late April. Aylesbury Road between Wards Road and Miles Road also remains closed as pipeline project works continue.

Weedons Ross Road seal widening

Weedons Ross Road will be one-way open to traffic travelling south (towards Rolleston), through the work area for the duration of the project to widen the road. The work area is currently from Kingsdowne Drove to Johnsons Road and will move south as sections are completed. A detour is in place.

Pre-seal repairs are taking place on Hororata Dunsandel Road between McWhas Road and Burgess Road, Coaltrack Road between Beattys Road and James Street, Malvern Hills Road between SH72 and Bush Gully Road, Grange Road between Telegraph Road and Highfield Road, and Kivers Road between Grange Road and Ayelsbury Road. Repairs are also taking place on Telegraph Road between Essendon Road and Bealey Road and between Courtenay Road and Highfield Road.

Repairs are taking place on Andrew's Bridge, Mt White. A culvert is being built on Algidus Road between Coleridge Road and Coleridge Intake Road.
