

SDC Lincoln Town Centre Selwyn Sounds Competition 2025 **Terms and Conditions**

- 1. Information on how to enter and prizes form part of these conditions of entry. Entry into the competition is deemed acceptance of these terms and conditions.
- 2. In these terms and conditions:
 - a. the "Promoter" is Selwyn District Council ("SDC"), 2 Norman Kirk Drive, Rolleston, New Zealand.
 - b. the "entrant" ("you") is an individual that signs up to the Lincoln Town Centre upgrades email list on SDC's website as contemplated by these terms.
- 3. The promotion is open to Selwyn residents. Employees of the Promoter and any agency involved with this promotion, and the immediate families of such employees, are not eligible to enter. Immediate family includes the spouse, defacto spouse, child, parent or sibling.
- 4. Competition opens 18 August 2025, closes 1 September, 2025. Winner announced 2 September, 2025.

- 7. The winner will be selected at random using an online randomiser and notified via email.

- 9. By entering the draw, you agree to provide us your personal information (first name, last name, and email address), which you authorise us to collect for the following purposes:
 - a. communicate with you about this promotion;
 - b. to send you emails from SDC regarding the SDC Lincoln Town Centre project; and
 - c. otherwise as set out in these terms.
- 10. You can unsubscribe from future communications via the link provided in emails.
- 11. SDC will otherwise collect, retain, use and disclose any personal information we collect about you in accordance with our privacy policy which is available here.
- 12. The prize winner will be announced on the SDC Facebook page the week following the competition closing date.
- 13. If the prize is not collected within 10 days of the winner being contacted, the Promoter reserves the right to redraw the prize under the original terms of the prize draw.
- 14. Once awarded, the Promoter is not liable for any part of the prize that has been lost, stolen, forged, damaged or tampered with in anyway.
- 15. If the prize becomes unavailable for any reason beyond the Promoter's control, the Promoter may in its sole discretion decide to provide an alternative prize.
- 16. Entrants must be over 18 years old.

Neither the Promoter nor any other entity associated with this promotion will be responsible for any late, lost, misdirected, corrupted, incomplete or incorrectly submitted entries, including but not limited to entries not received due to technical problems or human error. The time entries are deemed to be made will be the time the entry is received, not the time the entry is submitted by an entrant.
- 18. The Promoter reserves the right to disallow entries in its absolute discretion and without giving reasons.
- 19. The Promoter reserves the right, at any time, to verify the validity of entries and determine the eligibility of entrants (including an entrant's identity and age) and to disqualify an entry or refuse to award a prize where false or misleading details have been given by an entrant, or where an entrant has behaved in a fraudulent or dishonest manner, or otherwise than in accordance with these terms and conditions or the spirit of the promotion.

By entering this Promotion, entrants agree to the use of their names, photographs, and likeness for promotional advertising purposes without charge, and agree to make themselves reasonably available for this purpose. The ensuing copyright will rest with the Promotor, without any claim to compensation from the entrants.
