Comments: Having travelled through various Alpine countries in the world I find the lack of foresight of SDC in not promoting the landscape and tourist activities of Springfield very disappointing. Observing from a distance over the past 25 years it seems SDC is complicit in preventing growth further west than Darfield.

# Q2 Priorities:

I belive SDC should :-

Resolve the current land issues in Springfield,

Improve the supply and quality of Springfield's water

Seek EOI's from existing land owners in Springfield if they wish to be part of its growth

#### Q3 Growth in the remainder:

Most definitely. SDC in their 2031 Plan is allowing for a massive development at Crystal Valley or Porter's Heights, therefore with Springfield being the nearest Highway Town infrastructure should be in place to deal with the insurgence of employees and transit tourists.
