We the Georges and the Jeffs are in complete support of the Reserve at the rear of our land.

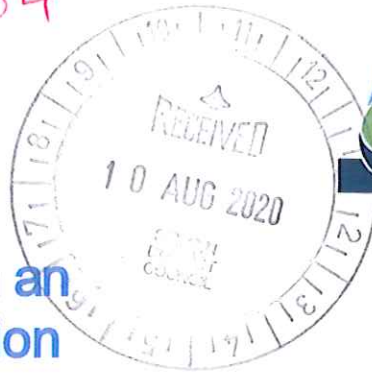


