Re Notified Plan Change

I am writing in support of the Porter Heights Ski Area Expansion.

I have skied on many fields overseas where the winter Olympic games have been held including Austria, France, America, Canada and Japan. I have only seen one field, which is Whistler, that is nearly as busy as our two Canterbury commercial ski fields. At 3 PM at Whistler all the skiers converge on a few exit trails which then become very congested. For the rest of the day there is never any risk of being hurt or hit by either snowboarders or other skiers.

I had a friend who was skiing with his wife at the age of 45 who was hit by a snow boarder at Mt Hutt. He suffered brain damage to the extent that he never worked again. Skiing on an overcrowded ski field is a very dangerous occupation.

It is my belief that the Mt Hutt ski field, and to a lesser extent the lower slope of Porter Heights, are grossly overcrowded and that Canterbury needs an extension of commercial ski field area. A village will allow people to stay and enjoy the area and make more use of our high country areas. I see no point in having large conservation areas preserved but then not allowing or encouraging people to go and enjoy our wonderful natural environment.
