Submission to SDC - Proposed Plan Change 25 - Rosalie J. Snoyink

For the last 45 years I have resided in Darfield and Glentunnel. I have skied and tramped in the Craigieburn Range with family and friends and hold the area in high esteem. I still frequently visit and enjoy the mountains and tussock hills, which are only a half an hour from where I live. I feel it is a privilege to be part of such a unique and beautiful area. I value its alpine and sub alpine landscapes, its tussock drylands, its unique biodiversity and eco-systems that are precious in a world of diminishing and degraded landscapes and ecosystems.

I oppose the proposed Plan Change Request because the land in question has outstanding natural values that should remain under the management of and protection by the Department of Conservation.

DoC purchased Crystal Valley with financial support of the Nature Heritage Fund. The land now provides a continuous corridor of protected land from the Southern Alps to the Canterbury Plains.

I supported the public purchase of the land, which would enable its permanent protection for present and future generations of New Zealanders in **perpetuity**. I expected that protection to be permanent and not to be removed at the request of a mostly foreign owned company, Blackfish Ltd.

Crystal Valley is part of a Canterbury Outstanding Natural Landscape as indicated in the 2010 Canterbury Landscape Review. Under the RMA Outstanding Natural Landscapes are recognised as having national importance and are to be protected from inappropriate subdivision, use and development. I oppose the SDC approving a Plan Change which seeks to remove the Outstanding Natural Landscape status from the land concerned. To do so ignores previous public processes and assessments which recognised the outstanding conservation values and provided for their permanent protection. The proposed plan change is in breach of Part 2, Section 6(b) of the RMA.

I have a particular interest in maintaining and enhancing water quality in the region's rivers and streams. Selwyn District Council has a poor history of stewardship and protection of water quality. The village type development proposed by Blackfish Ltd will degrade the Porter River and other streams in the area which are in a near pristine state. Sewage and waste water disposal systems necessary for the expected population increase will have an adverse effect on highly valued rivers and streams in the area. After the recent Christchurch earthquake broken sewage pipes resulted in raw sewage and other contaminants flowing into the Waimakariri River. The Porters Faultline is in close vicinity to the proposed development. The Alpine Fault could also cause significant damage to pipelines and infrastructure resulting in contamination of a near pristine area.

The effects of climate change on the region should also be considered.

There is already one half developed village in the vicinity at Castle Hill. The landscape should not be put at risk by another village development. I have no objection to further ski field village development at Castle Hill or at Springfield.

I oppose the development in Crystal Valley because it will seriously impact on biodiversity. The Canterbury Plains within the Selwyn District have probably suffered the highest level of biodiversity loss of any ecological region in New Zealand. I understand that there is less than 5% indigenous biodiversity remaining on the Canterbury Plains. This is an appalling loss and an indictment on local authorities. The Selwyn District Council by approving this Plan change would further encourage biodiversity loss in the Canterbury foothills region. From the Selwyn District Council's website on biodiversity I've taken the following quote:

"The uniqueness of New Zealand's biodiversity means the responsibility for its continued existence is entirely up to us".

I request the Selwyn District Council take that responsibility seriously and **decline** this application to rezone public land in the Craigieburn Range.

My/Our Submissions is: : I strongly oppose the proposed plan to rezone Rural (High Country) land to a proposed Ski-Area Sub Zone at and adjoining the Porters Ski Field in the Craigieburn Mountain Range. My reasons for this are listed below:

It is widely acknowledged that the biggest threat to biodiversity worldwide is habitat destruction and disturbance. New Zealand has already lost vast areas of primary natural habitat with the two main waves of human colonisation. Therefore, what little natural habitat we have remaining should be protected against further losses.

Habitat disturbance is also known to facilitate the invasion of exotic weedy species that can then drive the loss of natural biodiversity through processes such as competition for shared resources. This is a major issue in New Zealand where exotic plant species now well outnumber the native flora.

Habitat disturbance is also known to increase rates of hybridisation between closely related species. In natural New Zealand alpine systems, hybrids are relatively rare in comparison to their parents. But, as much of New Zealand's alpine flora evolved relatively recently with the uplift of the Southern Alps, habitat disturbance is likely to increase rates of hybridisation amongst closely related species such as Celmisia or Aciphylla and subsequently lead to the loss of endemic species.

The area proposed for development is potentially one of the few remaining eastern most locations where kea now live. Kea are already a threatened species, and much of this threat comes from direct interaction with humans (e.g. being fed human food, such as chocolate which is lethal to kea), or human structures (e.g. kea eat are fond of eating lead found on many buildings and this consumption eventually leads to their death).

Advertising brochures for the proposed resort promote the resort's potential for increased access to summer activities such as mountain biking and walking. However, these activities are already available within the Craigieburn Range and surrounding area. Furthermore, the increased number of people and buildings within the area will detract from the

experience that recreational users gain from visiting area in its current state. Therefore, I believe that the resort style complex that is currently being proposed is completely inappropriate for a high country area that is relatively free from human interference.

I am concerned that this project will not gain the investment and support needed from people buying properties in the resort, especially in the current economic climate. This could result in the abandonment of the resort, after the destruction to the environment has already occurred. Moreover, there is already an alpine village (Castle Hill Village) within the Castle Hill Basin where people can buy/rent property to when visiting the area.

For the reasons stated above, I am strongly opposed to the rezoning plans.
