The NZ Snowsports Council (NZSC) is an umbrella body representing the following organisations: Ski Areas Association NZ (Commercial Ski Areas, Club areas and suppliers) NZ Snow Industries Federation (importers, wholesalers, retailers/rental outlets) Snow Sports NZ (Competitive snowsports organisations) NZ Mountain Safety Council

The NZSC was established in 1988 to encourage increased participation in snow sports for New Zealanders and overseas visitors of all ages and abilities. Our vision: Growth in snow sports for all – snow for life

Growing participation in snowsports and recreation has been and continues to be the NZSC's aim on behalf of its member organisations. We all have a vested interest in this aim.

The industry measures its growth by seasonal ski area visits (number of lift passes sold). In 1988 commercial ski areas achieved 616,000 ski area visits. In 2009 ski areas achieved 1,536,000 (record for the industry) ski area visits.

Investment by ski areas has proven that growth is eminent and will continue. The increase in ski area visits and resulting growth over the past 22 years is a result of the following:

- 1. Investment in lifts, snowmaking and customer services
- 2. Increased and improved marketing (collective and individual marketing budgets)
- 3. Improved access to ski areas main highways and mountain roads
- 4. Advent of snowboarding and other snow sports such as free skiing
- 5. Increase in the Australian market eg direct flights into the southern lakes area

The NZSC and its member organisations have supported industry members throughout this period as we know investment in new developments help achieve our vision and aim.

The Porters Proposed Expansion is a great example of a new development which will generate further growth in snow sports and recreation in NZ and the Canterbury region.

1. Investment in lifts, snowmaking and customer services

The Crystal Valley development and Porters Basin upgrade with new lifts, snow making, village and state of the art customer services will result in further snow sports growth making Porters a very viable and attractive destination equal to any snow sports destination anywhere in the world.

2. Increased and improved marketing (collective and individual marketing budgets)

The increased growth highlighted above has occurred mainly in the Southern Lakes Region (Queenstown and Wanaka) and Mt Ruapehu Region. Both regions have the benefit of two or more large developed ski areas strengthening each region's attractiveness as a snow sports and recreation destination.

The Porters expansion will provide Canterbury with two large developed ski area destinations as well. Canterbury will be seen as a more attractive destination for snow sports and recreation. It will be on the same level as the Southern Lakes and Mt Ruapehu regions both experiencing huge growth in the past two decades. From a marketing point of view Canterbury can be marketed much more strongly off shore in Australia particularly and in the North Island on the same basis offering two well developed and accessed ski area destinations.

3. Improved access to ski areas - main highways and mountain roads

The access to Porters Ski Area has always been good with a main and well maintained sealed highway servicing Canterbury and the West Coast with a short ski area gravel road to Porter's ski area car park and lifts.

The Porters expansion improves the current access considerably with the addition of a short tar sealed road to the village and gondola accessing the chairlifts in Porter's Basin and Crystal Valley.

Improved access to any ski area results in increased growth especially in present and future times where participants want to arrive at destinations as quickly, efficiently and safely as possible. Examples of how growth is enhanced by improving access to ski areas include the sealed road to Coronet Peak only 25 minutes from Queenstown, sealing the Crown Range Road (including barriers) has increased Cardrona's visits out of Queenstown, sealed roads at Turoa and Whakakapa at Mt Ruapehu. Interestingly the four ski areas mentioned have experienced the most growth of any of our commercial ski areas in NZ.

4. Advent of snowboarding and other snow sports such as free skiing

Snowboarding has helped the industry increase participation in snow sports over the last 15 years. Currently 38% of ski area visits are snowboarders.

It is widely known world wide that snowboarders do not like surface lifts such as t-bars, platters and tow ropes. Surface lifts are hard to ride and they find chairlifts much easier being elevated off the snow.

The Porters expansion with new chairlifts in the Porters Basin and Crystal Valley will enable further growth attracting more snowboarders to the ski area. Ski areas serviced by chairlifts have more snowboarders participating.

5. Increase in the Australian market – eg direct flights into the southern lakes area

The Australian tourism market is the most important off shore market we have annually and this includes winter. Numbers out of Australia for snow sports have increased dramatically since direct flights started into Queenstown. We are now attracting 80,000 Australians a year for snow sports and with increased marketing efforts this figure can continue to grow.

Christchurch being our second largest international gateway and having many more international flight arrivals than Queenstown is in a perfect position to handle more Australian visitors in winter. The Porters expansion will attract more Australians to Christchurch and being only a short distance from the ski area and village is ideally placed from an access point of view.

I am very happy to attend any planning hearing regarding the Porters Expansion to expand on these points.
