I beleive this plan is an incredible idea. Installing a gondola will greatly reduce the risk and adverse environmental impacts of having an access road. I do however wish to voice some concern over putting a gondola unit station up to the peak. There is a reasonable likelihood of an high magnitude earthquake over the next 50 years that will have consequences for the area. Infrastructure that is located on peaks and ridges is subject to much higher levels of ground acceleration in an earthquake. Has this been taking into consideration for design of the gondola?

Also given that snowmaking is proposed as a solution to enable ski-in access to the gondola, Is this going to require construction of new snowmaking reservoirs? If so, where are the reservoirs going to be located?

I strongly recommend that any reservoirs be located below critical infrastructure.

Lastly the siting of the area is not totally clear to me. Have there been geotechnical investigations to assess the risk of avalanches, landslides, rock-fall, and the general stability of the slope where the village is to be constructed.

 I was born and raised in Arthur's Pass in the Arthur's Pass National Park and brought up with the conservation and mountain recreation values embodied therein. I completely respect the need to keep National Parks pristine but at the same time this must be balanced by well-planned development in less-sensitive areas.

I believe the Crystal Valley development proposal is both desirable and practical for the following reasons:

* If some of our mountain regions are going to be available for recreation and a mountain experience to those of only average physical fitness and ability then skiing/snowboarding provides this with the least infrastructure, visual and noise intrusion.

* The basic concept of keeping vehicle and visitor accommodation in the valley with access to the ski slope by way of a high-speed enclosed lift (gondola) is totally in accord with European best practice; exemplified, for instance, in Switzerland where environmental considerations over-ride all others.

* Alternative sites for such a ski area are non-existent. A minimal list of essential requirements for a ski area includes:

Proximity to a major population centre

Proximity to an international airport

Suitable terrain

Suitable elevation/climate to facilitate natural snowfall plus snow-making

* The valley-resort concept minimises journeys, reduces vehicle emissions and avoids city drivers having to negotiate difficult and sometimes dangerous mountain roads.

* Current patronage at the two commercial areas serving day-visitors from Christchurch is presently at capacity. The next phase of development will need to meet the higher environmental and conservation expectations which were not in place when we started Porter Heights. The Crystal Valley proposal satisfies these.
