Overseas examples such as Wistler/Blackcomb demonstrate the strength of village-based ski fields. They are the way of the future.

This field could be a huge economic benefit to Canterbury and could transform Canterbury as a winter destination.

The environmental issues are all capable of management.

There are very few transformational economic opportunities for Canterbury and this is one of the very few that do exist.

I make these judgments based on skiing and mountaineering experiences in the Canterbury Alps (and elsewhere) going back to 1966, together with experience of mountain destinations in a range of countries including Japan, Canada and France.

Let's get on and do it!
