My/Our Submissions is: In favour of the proposed plan change I/We seek the following decision from the Council for the following reasons: I am in direct support of the plan change 42 which is the 'Proposed changes to the Temporary Activities provisions of the Selwyn District Plan'

Due to the recent population growth within the Selwyn district it is inevitable that an increase in the number of temporary activities will increase in the area, it is agreed that many temporary activities could bring benefit into the region and should be actively encouraged by the local authority. However the existing plan has and will continue to enable business and undesirable ventures to take advantage of the existing policy whereby the Council have little, if any ability to intervene when the temporary activity becomes a community problem.

1. Limit temporary activities

By limiting a repetitive temporary activity to once in any one month ensures that the community is not regularly impacted by the temporary activity.

- 2. New parking / traffic generation threshold Due to the significant increase in traffic there has been a major increase of accidents and fatalities within the Selwyn district, temporary activities may generate high volumes of traffic that will have an adverse affect in the area. What is deemed to be adequate traffic management? Further elaboration may be required.
- 3. Inserting noise related definitions for temporary activities Noise levels, the type and duration of noise generated by a temporary activity can be extremely disrupting and distressing to the residents in the immediate and surrounding area

Noise related definitions need to be clearly defined by this proposed change.

4. Signage

PC42 has specified that temporary signage is exempt. It is felt that the regulations to temporary signage should be clearly defined and enforced as to the definition of "temporary". A temporary activity could have signage for extended periods of time.

My/Our Submissions is: : This plan change is just a knee jerk reaction to the situation that arose from the Horror Maze. There is no need for all of the proposed plan change except the temporary election signs that seems to be a way of achieving a sensible approach to this situation. Plus the noise levels should be altered to conform with the standards proposed.

the principle part of the change for temporary activities is an attempt to change an effects based plan to an activities based plan and it will be to the detriment of the plan itself by creating more difficulties for the citizens and increasing the need for consents due to the restictions placed on activities. Restrictions on activities that have no record of creating problems in the past except for the one mentioned. The plan change as proposed will capture a significant number of activities that are not mentioned in the permitted list.

The proposed traffic plan is just a nonsence as some activities will take place at such short notice that there will simply not be sufficient time to prepare one. The limiting days to once a month will affect more people than is realised. This plan change is typical of Selwyn planners not being able to forsee the outcomes of of this poorly thought out change and will not achieve the intentions hoped for making it more difficult for Selwyn residents to partake in any temporary activity.

I/We seek the following decision from the Council for the following reasons: The only decision that is open to the Council is to include the election signs proposal and the noise levels as an addition and amendment to the Plan. Discard the remainder in their entirety to save having to introduce a subsequent plan change to make Temporary Activities workable. If possible to prevent the Council being in the situation it was with the Horror Maze wording should be altered or included in the Plan to more succintly define an activity that is not permitted not to try and list the permitted activities and regulate the number of times per month. This process will not be successful and the only outcome will be that resource consents will be needed where they are not needed now, to make matters worse there is no history of interuption of life styles with the present Temporary Activities.

Implement the noise and election signage changes. Define only activities that are deemed not desirable to be permitted instead of attempting to list permitted activities thus keeping the Plan predominately as an effects based plan and not a hodge podge mixture of both.

Submission Plan Change 42

The specific provisions of the proposed plan change that my submission relates to are:

- Definition of Temporary Activities
- The frequency of single Temporary Activities
- Insert NZS6802:2008 Acoustics Environmental Noise into the Rural Volume
- Traffic Management for Temporary Activities

My submission in SUPPORT is:

I support the proposed new definition of "Temporary Activity" to list out specific activities that are anticipated to be encompassed by this definition. This will provide greater clarity as to what is a "Temporary Activity". It will enable community events to take place as temporary activities, but events that are clearly commercial in their nature, such as the Horror Maze, would need to seek resource consent.

I support the alteration to limit the total number of days per month that a single event i.e. non- consecutive days, can operate. The new limit will be no more than one single day event per month i.e. a total of up to 12 per year. The reason I support this change is it will reduce the concentration of events like the Horror Maize where the residents were subjected to unreasonable noise from 9pm to 12 am (and sometimes later) on a weekly basis. However, it will still allow monthly events like "Farmers Markets" to occur.

I support the insertion of reference to section 6.3 of NZS6802:2008 Acoustics –Environmental Noise in the definition of "noise limit" of the Rural Volume. This amendment will enable the application of good practice in taking into account noise of "Special Audible Characteristics" e.g. noise of terrified screaming by young people, during the night time in both residential and rural areas.

I support the pragmatic proposal that a Traffic Management Plan would only be required if the "Temporary Activity" is likely to exceed the current permitted traffic generation limits. This will help improve road safety and potentially mitigate the concerns raised (in a traffic report prepared by Beca Infrastructure Ltd for local residents) on motorists behaviours and traffic movements arising from the Horror Maze operation. These were:

- · a peak hourly traffic flow of 130 vehicles per hour;
- as there was no lighting on Marshes Road this led to some vehicles passing the access and then Uturn on Marshs Road to access the site; and
- during the survey late breaking was noted as vehicles slowed to turn right into the site, which resulted
 in heavy breaking by following vehicles that had not anticipated this slowing.
