PRIVATE PLAN CHANGE 49, Selwyn District Plan

Z & S Croft and J K Williams request to rezone Rural (Inner Plains) land to Living 3 at the corner of Lincoln Tai Tapu Road and Hauschilds Road, Tai Tapu, Clause 5 of the First Schedule, Resource Management Act 1991.

Private Plan Change 49 (PC 49) proposes to change the Selwyn District Plan (Maps and Plan Text) to rezone two properties that are 8.1 hectares in size collectively from an existing Rural (Inner Plains) Zone to Living 3 to facilitate the subdivision and development of approximately 16 rural residential households. The subject land is located on the western boundary of Tai Tapu on Lincoln Tai Tapu Road (Lot 1 DP 436571 certificate of title 537135) and Hauschilds Road (Lot 2 DP 436571 certificate of title 537136). PC 49 proposes the following amendments to the Selwyn District Plan:

- amend the district planning maps to rezone the subject land from Rural Inner Plains to a Living 3 zone
- \cdot incorporate an outline development plan to coordinate and guide the future development of the site
- · propose site specific rules to manage flood risk, waste water and internal roading arrangements
- · incorporates land use rules and subdivision assessment matters to manage the effects of any future development on the site in accordance with the proposed amendments to the Living 3 zone provisions.
