Background of the Submitter and General Further Submissions Information

The Harts Creek Streamcare Group (hereafter referred to as 'HCSCG') is made up of farmers and landholders who own and/or farm land immediately adjacent to Birdlings Brook and Harts Creek near Leeston, Canterbury. These waterways are adjacent to and downstream of the Proposed Plan Change 62 land area.

HCSCG was formed in the 1990's when a visiting fly-fisherman (Allan Fife – botanist) recognised there was a decline in species in Harts Creek. Allan liaised with a local farmer (Peter Chamberlain) and Peter instigated the creation of the HCSCG with help from David Hewson (formerly Environment Canterbury 'ECan') and farmer, the late Colin Patterson.

What resulted from these initial beginnings was 'A Day on the Creek' Field Day held on 6 August 1995 when 60 people including environmental consultants, ecologists, biologists, foresters, ECan representatives and farmers came together to discuss and view the state of the waterways. From here significant regeneration of Birdlings Brook and Harts Creek has taken place with the primary aim of improving the water quality and quantity of these waterways through fencing out of stock, clearance of stream blockages, riparian planting and a shift to more environmentally sustainable farm practices. Significant improvements to the waterways have emerged over the years and the area is a major success story for what can be achieved through non-regulatory projects in partnership with landholders, regulatory authorities, the Department of Conservation, Ellesmere Lions Club and Te Waihora Trust. The Harts Creek Walkway was also created and is an important and widely visited recreational feature of the Leeston, Ellesmere and Selwyn districts. All projects have been funded in part by all of these entities including the landholders.

HCSCG focuses on positive outcomes, interactive relationships, environmental responsiveness and 'on the ground' practical solutions. The group has a significant interest in Proposed Plan Change 62 (PPC62) and would be agreeable to engaging in any discussions relating to the matters raised in the following further submissions. No consultation has occurred to date with HCSCG relating to the provisions of PPC62 and it is very concerned that the proposed rezoning will have detrimental effects on surface and groundwater quality and quantity in the area.

The submitter does wish to be heard in relation to these further submissions and would support attending pre-hearing meetings in relation to this proposal.

The Harts Creek Streamcare Group could not gain an advantage in trade competition through these further submissions.

The Harts Creek Streamcare Group is an entity which has an interest in the proposal that is greater than the interest the general public has; its members are affected by the content of these further submissions.
