Moirs Lane has been recognised as part of the Christchurch - Little River Railtrail. It is important that any upgrade to Moirs Lane includes the provision of an off road cycle path. Furthermore we would like to provide the residents of the two adjoining subdivisions with easy access to the bike trail by the provision of cycle ways suitable for people aged from 8 to 80 years old from Springs Road to Moirs Lane. Shared paths on the edge of main roads do not meet this description.
