

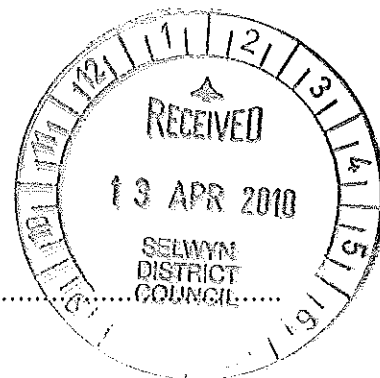

The inappropriate proposed ZONING of the land known as
Helpet Park. That is the living 2 & 2A zoned land between Lowes Road
Lincoln Rolleston Road, Spiny Star Rolleston Road & the boundary of the Helpet Sewerage
Plant (give details)

3. *My submission in ~~SUPPORT~~ / OPPOSITION is: The area of land is located close to the

centre of Rolleston. There for its most appropriate
zoning is for a living ONE zone. This is now
more appropriate considering the removal (shrinking)
of the airport noise contours away from
this part of Rolleston. It is clearly obvious
and in fact ridiculous, to have (5000 Sqn
and 10,000 Sqn sections in the middle of a
living ONE zone.
Parts of this locality were zoned living
2A (1 HA average) due to its proximity to
the noise contour. If the entire area is
not considered suitable for a living ONE
zoning, then at least the area zoned
living 2A should become living 2.
