Development falls outside of CRPS:

We do not believe there is a need for the intensive development of the land as the demand for housing in Christchurch and surrounding districts has reduced following the earthquakes. However, perhaps zoning the land as rural-lifestyle for less but larger sections would better manage the impacts of the development. A lack of developed green/park spaces in this area is a concern and it is noted that land was set aside for the under the CRPS.

Traffic planning and management:

The impacts on traffic, including access to public transport, have not been adequately addressed and cannot be overstated. At the moment traffic backs-up from the Levi/Masefield/Lowes Road roundabout back past Ruby Drive most weekdays between 4-5:30pm. It is also difficult to get on to

Levi Road in the morning between 7:30-8:30am and the addition of 660 properties using that section of road has not been properly considered or addressed. Levi Road is also very narrow with no room for parked cars or turning traffic; we have had a car damaged that was parked outside our property on Levi Road. A significant increase in traffic turning in/out of a road opposite Ruby Drive will have a significant impact. Cycling access across SH1 via Levi/Weedons Road is also a hazard due to increased traffic on Levi Road and no considered infrastructure. This would also become considerably more dangerous with the addition of 660 properties and the associated traffic. Without considerable investment into roading infrastructure, issues will only be compounded.

#### Additional notes:

We note from other submitters that the proposal does not consider, and the developers have not consulted with; the Ministry of Education on the impact on schools, the CIAL on the flight path controls, Waka Kotahi on the impacts on roading, ECAN on the impact on water and sewage. We believe that the proposal needs to be refused at this point and the developers need to reconsider their plans as per above. Rapid and large scale development without consideration of the necessary infrastructure demonstrates poor long term planning from the council and will degrade services and accessibility for residents going forward.
