MINUTE NO 6 OF COMMISSIONER DAVID CALDWELL ADDRESSING MATTERS RELATING TO THE NPS-HPL AND RECENT GUIDE TO IMPLEMENTATION

Dated 18 January 2023

1. I have made significant progress on finalising my Recommendation on Plan Change 80.

2. As the parties are aware, one of the key issues relates to the 18.1 hectares (approximately) of

LUC3 land within the site. The LUC3 land is "highly productive land" for the purposes of the

NPS-HPL.

3. I have received comprehensive legal submissions from Counsel for the Applicant, both in

Opening and in Reply. I have also had the benefit of comprehensive expert evidence from Mr

Mthamo and Mr Everest, together with planning evidence from Ms Seaton and Ms White. The

issue has been well traversed.

4. In the course of my deliberations I have become aware that MfE has published a Guide to

Implementation of the NPS-HPL. This was published on 16 December 2022.

5. While the Guide is simply that – a guide – I am of the view that it would be artificial to ignore

it. It would also be improper to have regard to it without providing the parties with an

opportunity to comment on the relevant provisions of that guidance. Without limitation, the

commentary on rezoning HPL to an urban zone at page 39 through to page 49 of the guidance

appears to be particularly relevant.

I anticipate that comments would be in the form of either legal submissions or a brief statement.

This includes Ms White as reporting officer. I do not consider there is a need for any further

evidence.

7. To avoid unnecessary delay I consider that a period of five working days to be more than

sufficient to provide any submissions/commentary. I consider that any

submissions/statements can be lodged contemporaneously. There is no need or benefit in a

sequential timetable. I therefore direct that all responses are to be filed by 3.00pm
