Operative Selwyn District Plan NOTIFICATION OF PRIVATE PLAN CHANGE REQUEST 82

Brookside Road Residential Limited has lodged a private plan change request (PC82) with Selwyn District Council pursuant to Clause 21 of the First Schedule, Resource Management Act 1991.

The proponent has requested changes to the Operative Selwyn District Plan to rezone approximately 110 hectares of land in Rolleston from Rural (Outer Plains) Zone to Living MD Zone and Business 1, to facilitate the future development of approximately 1,320 residential sites and two local commercial centres.

The affected land is located on the western side of the Rolleston township, bounded by Dunns Crossing Road, Brookside Road and Edwards Road.

The proponent has requested amendments to the Operative Selwyn District Plan that include:

- amending the District Plan provisions to incorporate a new zone, being the Living MD Zone, which
 gives effect to the Medium Density Residential Standards required by the Resource Management Act
- \cdot amending the District Planning Maps to rezone the affected land to Living MD Zone and Business 1 Zone
- incorporating an outline development plan to coordinate and guide the future development of the affected land.

The proponent has also requested that a qualifying matter be applied to restrict density to 1,320 residential sites within the area of rezoning, in order to address potential impacts on the safe and efficient operation of nationally significant infrastructure, being State Highway 1.

Any person or organisation may make a submission supporting or opposing any aspect of this private plan change request. Next steps

The Council has accepted this private plan change request for notification which enables public consultation. At a later date all submissions received will be summarised and published. Further submissions will then be invited allowing certain persons and organisations to support or oppose any of the initial submissions. An Independent Commissioner will then hear all submissions and make a recommendation to Council, after which the Council will decide whether to decline or approve the private plan change request. Any party who is not satisfied with the Council's decision may then appeal to the Environment Court.
