

Notification of an Errata to the Summary of Submissions on the notified Proposed Selwyn District Plan

Clause 7 of Schedule 1 of the Resource Management Act 1991

Date of public notice: Monday 31 May 2021

Selwyn District Council gives notice of an Errata to the Summary of Submissions, and calls for further submissions on the errata submission points only.



About the Errata to the Summary of Submissions

On Monday 19 April 2021 Selwyn District Council publicly notified the Summary of Submissions on the Proposed Selwyn District Plan, and called for further submissions. After the close of the further submission period, the Council was made aware of omissions and minor errors in some of the summarised submission points. As a result, the Council is calling for further submissions on the errata submission points from Monday 31 May 2021.

The Council has corrected affected submission points and they can be found in the Errata table. This notification only applies to submission points identified in the Errata table. Further submissions are therefore limited to matters in support of or in opposition to a submission point contained in the Errata table. All other parts of the Summary of Submission content remain unchanged and should be read in conjunction with the Errata table.

The Errata table and Summary of Submissions, together with full copies of the original submissions, can be found on the Council's website at www.selwyn.govt.nz/districtplanreview. You can also view this information online at Council libraries and service centres.

Who can make a further submission?

The following persons may make a further submission:

- A person who has an interest greater than the public in general.
- A person representing a relevant aspect of the public interest.
- The local authority.

How to make a submission

Further submissions can be made by using one of the following options:

- Download a PDF submission form at www.selwyn.govt.nz/districtplanreview, and:
 - email it to dprsubmissions@selwyn.govt.nz (Subject line: Proposed Selwyn District Plan Errata Further Submission)
 - post it to Selwyn District Council, Freepost 104 653, PO Box 90, Rolleston 7643, Attention: Proposed Selwyn District Plan Errata Further Submission
 - deliver it to a Council service centre in Darfield, Lincoln, Leeston or Rolleston.
- Pick up a hard copy submission form at Council libraries and service centres.

Written further submissions must be submitted on the Council submission form, or on Form 6 of the Resource Management Act 1991. Your submission must state whether you want to present your views at a Council hearing.

The closing date for further submissions on submission points contained in the Errata table is 5pm on Monday 14 June 2021.

Any person who lodges a further submission with the Council must, within five working days of doing so, serve a copy of the further submission on the person(s) who made the original submission(s).

What happens next?

- When the further submissions period closes, we will consider all the submissions in detail and produce a series of Officer Reports with recommendations regarding the submission points made.
- If requested by any submitter, we will hold a public hearing on the submissions received. At these hearings a panel of accredited commissioners will consider all submissions, Officer Report recommendations and any supporting evidence.
- Following the hearing we will give notice of our decision on the Proposed District Plan (and matters raised in submissions, including our reasons for accepting or rejecting submissions).
- Every submitter then has the right to appeal the decision on the Proposed District Plan to the Environment Court.
