Summit Up is Selwyn District Council's online database which summaries all appeal submissions received on the Partially Operative Selwyn District Plan, and the decisions requested by appellants. This summary includes the original appeals and s274 parties.

Summit Up is only a summary of the appeal and s274 party submissions received. To fully understand the issues raised by an appellant or s274 party, their submissions should be read in full (a link to the full submission is included in Summit Up), together with any supporting material that might have been included.

The online summaries of appeal and s274 party submissions have been designed so that users can easily find the information that is of most interest to them. This includes being able to find all submissions that have been allocated to the same hearing topic.

Summit Up has been set up as simple searchable tables:

- one for all the appeal submissions, and
- one for s274 party submissions.

This information sheet outlines the multiple ways in which a user can find relevant original or further submissions, for example based on 'Topic', 'Plan Reference' or submission type, in addition to searching for a specific submitter's submission. At the end of the document you can also find answers to most common questions.

What information on original submissions can you find in Summit Up?

Below the clickable tabs/quick links you can see the following screen. Information provided here is all about original submissions:

Here's what the columns show:

Column/Filter name	Description	Can I use this field to 'filter' submissions?
Topic	The Partially operative District Plan's topics are listed by shortcode, eg GRUZ or SASM	Yes
Provision Type	You can filter appeal by Objective, Policy, Rule, or Rule Requirement. The options of Chapter and Explanation have also been provided and are used where the submission point relates to either an entire Chapter or an area within the Chapter that doesn't have a Plan Reference, for example a Note for Plan Users. Submitter No	The unique identifier number assigned to individual submitters also provides link to the submitter's contact information. This information is necessary for purposes of serving a 274 party submission.	Yes

Using the filters to search original submissions

Search by ‘Appellant’ or ‘Submitter No’

If you want to see all submission points from a specific submitter you can do it by either their:

- Submitter No, eg DPR-0207 - select the small black arrow next to the ‘Submitter ID’ filter ‘and select the relevant submitter ID.
- Appellant, eg Chorus New Zealand Limited - select the small black arrow next to the ‘Submitter Name’ filter and select the relevant submitter.

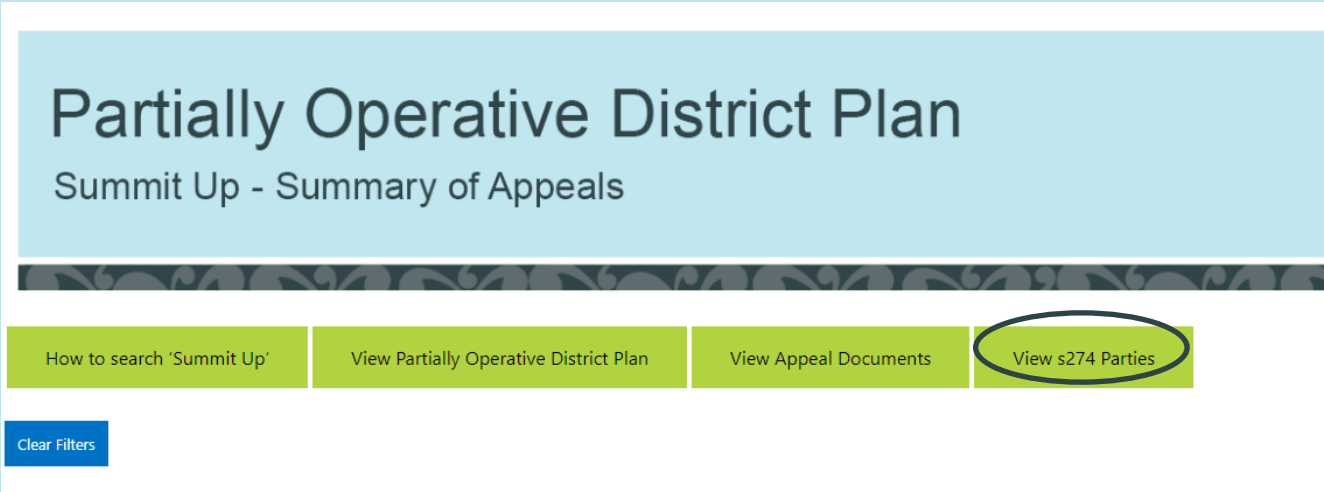
Search by ‘Provision Type’

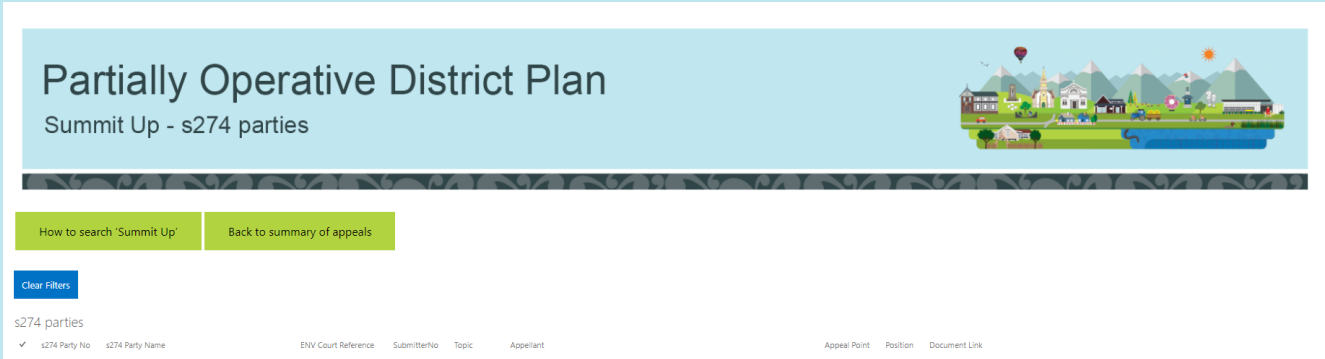

How to search s274 parties in Summit Up?

To find s274 party submissions click the 'View s274 Parties' tab at the top of the Summit Up page.



Once you open the page, you can see the following information on the screen:



Here's what the columns show:

Using the filters to search further submissions

Search by 's274 Party No' or 'Submitter Number'

If you want to see all further submission points from a specific submitter you can do it by their:

- s274 Party No, eg DPR-0440 - select the small black arrow next to the 's274 Party Name' filter and select the relevant 's274 Party ID'.
- s274 Party Name, eg Environmental Defence Society Incorporated - select the small black arrow next to the 'Submitter Name' filter and select the relevant submitter.
- If you made an original submission, s274 Party submitter ID will be the same as your original submitter ID.

Answers to most common questions

How can I find my original appeal?

You should have received confirmation from the Environment Court with the Environment Court Number. To find the summary of your submission, search the Summit Up database by using the filter ‘Submitter No’ or alternatively ‘Appellant’ (as outlined above) or ENV Court Reference’ (as shown below). In the search results you can also find a link to a copy of your original submission and any additional correspondence associated with it, such as where Council has sought clarification of any aspects of your submission while summarising it.

How can I find my s274 Party submission?

To find your s274 submission, search the Summit Up database by using the filter ‘s274 party No’ or alternatively ‘Appeal Name’. In the search results you can also find a link to a full copy of your further submission. Note that if you made an original submission, the appeal or s274 party submitter ID will be the same as your original submitter ID.

How can I find a copy of appeal or s274 party submission?

You can access a full copy of the original appeal or s274 submission in Summit Up under the columns ‘View Appeal Documents’ and ‘View s274 Parties’.

How can I see what decisions have been requested by the appellant?

This information is in the ‘Relief Sought’ column of the Summit Up table. In some instances you may need to refer to the full submission for more detail, by clicking the link supplied.

What's with all the acronyms?

The National Planning Standards require councils across New Zealand to start standardising district plan content. One aspect of this is using unique identifier codes and specific chapter names:
