1 Scope of Report

- [1] This Recommendation Report relates to submission points that were missed out or otherwise erroneously recorded during the compilation of chapter specific or rezoning request Section 42A Reports for the PDP. The Panel members were:
 - Malcolm Lyall
 - Raewyn Solomon
 - Rob van Voorthuysen (Chair)
- [2] The Section 42A Report addressing the missed out or otherwise erroneously recorded submission points was:
 - Section 42A Report, Report on submissions and further submissions, Missed and erroneously recorded submission points, Jon Trewin, 2 June 2023.

2 Assessments

- [3] Mr Trewin identified missed out or otherwise erroneously recorded submission points relating to the following PDP chapters and rezoning requests:
 - Strategic Directions
 - Part 1 Introduction and General Provisions
 - Energy and Infrastructure
 - Transport
 - Natural Hazards
 - Earthworks
 - Noise
 - General Rural Zone
 - Signs
 - Coastal Environment
 - Rezoning Requests: General Rural, Lincoln, Eastern Selwyn Commercial and Industrial, and Malvern.
- [4] In each case Mr Trewin set out the missed out or otherwise erroneously recorded submission point and assessed whether or not the submission point led him to recommend any further or different amendments to the PDP provisions. He also assessed whether or not the submitter had been unduly prejudiced by the submission point not being included in the respective original Section 42A Report. In each case Mr Trewin considered that no further amendments to the PDP were appropriate and that the submitter had not been unduly prejudiced.
- [5] We have carefully reviewed the missed out or otherwise erroneously recorded submission points and Mr Trewin's assessment of them. We agree with and adopt his assessments, which we found to be both detailed and helpful. We observe that in most cases the affected submitter received notice of the relevant Hearing and so would have been able to speak to their missed out or otherwise erroneously recorded submission point had they wished to do so. We note that did occur on some occasions.

3 Recommendations

- [6] Mr Trewin included a full suite of the missed out or otherwise erroneously recorded submission points in his Appendix 1. We do not recommend that the previous Section 42A Reports are retrospectively amended to include those submission points. That would be administratively inefficient and serve no useful purpose as those Hearings have long since concluded.
- [7] Instead, we recommend that:
 - (a) when the SDC notifies its decisions on submissions and further submissions in conformance with clause 11 of RMA Schedule 1, it informs the following submitters and further submitters of the existence of both Mr Trewin's 2 June 2023 Section 42A Report and this Recommendation Report.
