[3] In terms of matter (a), I note that the s42A Report references at [164] that both Te

Taumutu Rūnanga and Ngāi Tahu Whakapapa Unit have provided formal

correspondence that Mr Henderson does not whakapapa for Te Taumutu. I have

attached correspondence sought from the s42A Reporting Officer confirming such.

[4] Based on that correspondence, the submission cannot be used to represent the

position of Te Taumutu Rūnanga. Accordingly, as Mr Henderson has not been

identified as an affected party in his own right, I advise in advance that I am of a mind

that the submission be struck out as invalid pursuant to sections 96(3), (4) and

s41D(1)((c) of the Resource Management Act 1991.

In terms of (b) above, I remind Mr Henderson in terms of his expert evidence as to his

obligations to the Code of Conduct as set out in [3] of his evidence.
