Thanks Graeme. Just my 2 cents when you look into in more detail.

- 1. The model takes into account the Lake Ellesmere water levels as per the snip below.
- 2. Ultimately, they have to comply with the consent notice or get it changed but:
- * The highest flood levels within the site and the surrounding neighbouring lots is 1.91 m LVD1937. Adding a freeboard of 300 mm does not get anywhere near the 3 m.
- * It's not clear what the 3 m on the consent notice was based on. However, it has to be complied with regardless unless they get it removed.
