

RAKAIA HUTS CAMPGROUND RULES

General

- Camp fees are for one or two (2) adults only. All extra persons shall be registered on the registration sheet on arrival, and appropriate fee paid (see Campground Fees).
- Sites must be vacated by 11.00 am on the day of departure or by prior arrangement.
- Noise levels will be tolerated within the acceptable levels as outlined in the Council's District Plan until 10pm. Christmas and New Years are an exception.
- All campers must at all times be considerate and respect the peace and privacy of other campers and by leaving things clean and tidy. Enjoy your stay.
- **No drugs will be tolerated within Camp Grounds.**

Kitchen/Waste

- **Kitchen and appliances must be left clean after use.** Please ensure all personal belongings and rubbish are removed from kitchen.
- All wastewater **MUST** be disposed of at dumpsite located in front of toilet block.
- All empty cans (**ALUMINIUM BEVERAGE** cans only) can be disposed of in yellow drum next to dump site.
- **DO NOT** put fish waste in rubbish bins.
- No parking on grass in front of the kitchen.

Campsites

- All campsites must be kept clean and tidy.
- Grass clippings, flax etc are to be put in the appropriate piles located at the back of the storage area. These are not to be placed in the rubbish bins. A wheelbarrow is located at Errol's site if needed.
- All power cords to be suspended up off the ground.
- No digging of holes, removal or cutting of plants, shrubs or trees around any campsite.
- No stand-alone generators allowed without the written consent of the Council or its camp manager.
- Routine inspections of camp sites will be carried out from time to time.

Vehicles

- Strictly **NO** washing of vehicles.
- Always park at least 1.5m from all site boundaries. Vans, Campers must be 3m apart.
- No children under the age of 15 years may ride motorbikes in the campground.
- Speed limit in camp is 15km.
- All vehicles must maintain a current electrical warrant of fitness if connecting to a powered site.
- **No vehicles will be permitted on site without a current warrant of fitness (if required) and registration certificate unless approved in writing by Council.**

Dogs

- Dogs are permitted at the discretion of the Facilities Administrator prior to staying at the campground
- All droppings **MUST** be picked up and disposed of by the owner.
- All dogs must be kept on a leash and under strict control as set out in the Selwyn District Council Dog Control Bylaw 2012.
- Pet bedding **MUST NOT** be washed in campground washing machine.
- All dogs must have evidence of current registration.
