Dear Selwyn District Council, I am writing to formally submit my feedback on the proposed establishment of a Water Services Council Controlled Organisation (WSCCO) for drinking water and wastewater services. While I acknowledge the importance of maintaining safe and sustainable water infrastructure, I have significant concerns about the financial, operational, and transparency aspects of this proposal. 1. Transparency & Public Consultation Process • The consultation period is only three weeks, which is insufficient for residents to fully understand the long-term financial and service delivery implications. A decision of this magnitude should involve a more extensive public engagement process. • The Council has already appointed a chairperson to set up the WSCCO, which raises concerns that this consultation is a formality rather than a genuine effort to seek community input. • The consultation document is only 20 pages long, with limited financial details, particularly regarding debt repayment strategies. 2. Financial Concerns & Ratepayer Impact • The consultation document indicates that this proposal would increase council debt from 280% of rates revenue to 500% within five years. This is a significant burden on ratepayers, and it is unclear how the council plans to manage this debt long-term. • Ratepayers are already facing 14% annual rate increases under the Long-Term Plan. The proposed WSCCO model suggests that an average household could see an additional \$600+ in rates within three years. • There is no clear debt repayment strategy outlined. If debt reaches 500% of rates revenue, what measures will be taken to avoid further rate hikes? 3. Alternative Approaches & Comparisons with Other Councils • The council states that maintaining in-house water services is not viable due to legislation, funding constraints, and compliance costs. However, Christchurch and Dunedin have opted to keep their water services in-house. Why is Selwyn taking a different approach, and why hasn't this been clearly explained? • Splitting water services between the WSCCO (drinking water & sewage) and the council (stormwater, land drainage, and water races) seems inefficient. This creates duplication in staffing, equipment, and operations, which could increase costs rather than reduce them. • Many councils require developers to contribute to infrastructure costs through development contributions. Has the council considered increasing

developer contributions instead of placing more financial pressure on existing ratepayers? 4. Request for Further Information & Extended Consultation To ensure that residents can make an informed decision, I request the following: 1. A detailed breakdown of the financial impact of this proposal, including long-term debt repayment strategies and the overall impact on rates beyond the water component. 2. An explanation of why Selwyn is not following Christchurch and Dunedin in keeping water services in-house. 3. A comparative cost-benefit analysis of separating water services (WSCCO for drinking water/sewage vs. in-house stormwater and drainage). 4. An extension of the public consultation period to allow more residents to engage with this important decision. Conclusion Given the significant financial implications and lack of clarity around debt management, I urge the council to reconsider this rushed process and provide the community with more detailed financial analysis. Transparency, fiscal responsibility, and a long-term sustainable funding plan must be the priority. I appreciate the opportunity to provide feedback and look forward to your response.

#### **Water Chlorination**

#### **Ensuring safer water - chlorination**

Under the Water Services Act 2021 (passed in November 2021), all councils must provide residual disinfection (chlorine) for all public drinking water supplies, unless an exemption from chlorination is granted by the drinking water regulator, <a href="Taumata Arowai">Taumata Arowai</a>

(https://www.taumataarowai.govt.nz/)\_

Chlorination is widely and safely used in New Zealand and around the world for both short-term and permanent treatment to ensure protection against contamination.

The Council has made a major investment in recent years to upgrade its water supplies to have a multi-barrier approach using filtration, UV treatment and other barriers at all our water treatment plants. The required chlorination provides protection for water within the reticulation system (pipes and storage tanks) between the treatment plant and peoples taps.

In response to the requirements under the Water Services Act, the Council has chlorinated all its water supplies. Following consultation as part of the Long-Term Plan 2021-2031, the Council indicated that we would work with Taumata Arowai to clarify the requirements for gaining an exemption and consider the costs and rating options for upgrades to gain exemptions for our supplies.

#### **Exemption applications**

Selwyn was the first council in the country to file for an exemption from chlorination. This application was for an exemption for the Rakaia Huts water supply.

The Council's initial application for an exemption was declined in April 2023. Following further work in February 2024, Taumata Arowai granted [PDF, 81 KB]

(https://www.selwyn.govt.nz/\_\_data/assets/pdf\_file/0005/2137910/Media-Release-Selwyn-District-Council-Granted-Chlorination-Exemption-for-Rakaia-Huts.pdf) the Council an exemption from chlorination for the Rakaia Huts water supply, subject to further conditions being met.

Based on the requirements for the Rakaia Huts, the Council estimated that meeting the requirements to remove chlorine from the majority of our supplies would cost \$82.6 million and the ongoing cost if an exemption was granted for a scheme would be an additional \$231 per year on the existing targeted rate for affected ratepayers.

Due to the impact on our ability to deliver safe water and the significant cost to upgrade our infrastructure, the Council decided in the Long-Term Plan 2024-2034 to continue chlorinating our supplies (including Rakaia Huts) and not to apply for further chlorine exemptions.



In principle, I think that transitioning to a CCO (with the higher borrowing limits) would be a good thing for the people of Selwyn and ratepayers, however I think that the consultation document, and this consultation does not accurately reflect the risks by having a separate commercial entity controlling out water supply. I want more information about how this will work, and how Council will maintain control of our water supply (how will Council make sure that the CCO ensures everyone has access to clean drinking water and waste water systems, and how will the CCO ensure that access to water is affordable for everyone). Also in addition, how will the CCO respond to advocacy from community, for example, Selwyn's nitrate levels are very high compared to other places in New Zealand, and well above international safety standards (I note that they are within New Zealand's standards).
