First of all I just want to mention that I recently completed the 'Making Good Decisions' course so am trained as a RM commissioner. I don't know if that qualifies as a conflict of interest exactly, but I thought I would mention it. With the above declaration, I offer a few comments. 1. This is cautious support for the new entity i.e. a CCO to run the delivery of drinking and waste water services. I think it has the potential to be a more efficient organisation. 2. Having said that, I would have liked to see a more fulsome discussion about the benefits and costs of creating a stand-alone entity. There are some in the community who will effectively see this as distancing of a vital community asset from day-do-day Council business. You have put forward some good arguments as to why this could be a more efficient model, but it could come with risks if Council does not have full control of the asset(s) into the future. 3. The current Ngāi Tahu claim going through the courts is most interesting in terms of Tino Rangatiratanga. Even if their claim fails, I think there will be some legal precedents set, and it would be good to see Council being more clear about what you will do to respond. I say this because at the moment there is quite coded language about 'partnership' in the document presumably because you didn't want to rile up the haters - but in my view the way of the future is going to be to have greater input from tangata whenua and mana whenua. I would like to see Council being very clear (proudly and with respect) about what this means for our communities - and that it could be very good for everyone. Perhaps painting some positive benefits about co-management and co-governance. 4. My final point is a top priority for me. The governance of these entities is going to be critical. You allude to 'experts' in water infrastructure funding, long-term debt management, and water delivery. These are laudable but I suggest that both management and governance of these entities should also include environmental experts e.g. people who understand the setting of environmental limits and targets, impacts of over-allocation of the ecology of streams, lakes and rivers, etc. This is not mentioned in the documents. Further, in terms of governance it would be good to be clear about the role of mana whenua (i.e. that they will have seats at the table as is their right under Te Tiriti). Finally, it would be good to see a good and robust appointment process for all governors to

ensure that the entity is governed by a wide diversity of community voices - not the same old perspectives. Some active recruitment to ensure that a diversity of skills apply for, and are appointed to, these boards will be critical for the long term success of the entity if it goes ahead.

This gives the impression that the act of ticking Yes or No is the most important part, rather than the ability to engage with the issues fully. I believe this ordering undermines the consultative process and discourages detailed public input. • One has to tick a box before the submission can be accepted, there fore I ticked NO to each option. 2. Need for Further Information Before Indicating Preference I feel there are several key concerns raised by Lincoln Voice and others in the community that need to be fully addressed before I can make an informed selection on a preferred option. These questions are critical to understanding the real costs, risks, and impacts of the WSCCO model versus the in-house model. The tight timeframe and the rushed nature of this consultation process increase the risk of poor decision-making that could have serious long-term impacts on ratepayers. 3. My view is that the ONLY benefit is to borrow more (i.e. additional cost of debt) to do the work faster rather than prioritise the asset renewal programmes over time.
