APPLICATION INFORMATION FOR STOCK WATER RACES RELOCATION OR NEW RACES

Included with the following instructions are:
An application form
A copy of the 2008 Water Race Bylaws
A copy of Selwyn District Council's Water Race Policies
And a water race map of the area concerned.

Along with the application form and the appropriate payment please provide the following information to Council for processing.

- 1 Long section showing current ground level and proposed race invert level.
- 2 Name and contact details of the contractor hired to do the physical works.
- If water race is relocated into the Road Corridor,
 An application to 'beforeudig', (pamphlet attached), is required to receive information regarding other assets in the road corridor.
- 4 Written authorisation from other affected landowners.
- Resource Consent from Environment Canterbury
 NOTE: It is the applicants responsibility to consult with Environment
 Canterbury to determine whether consent is required.

Upon receipt of your application including all supporting documentation from Environment Canterbury, other utility providers and the water race level data, a Council representative will contact you to meet you on site to discuss your proposal.

Any and all physical works associated with this water race relocation may not be started until written approval is received from Council. Failure to comply with this condition will result in your application being declined.

What is beforeUdig?

The beforeUdig service enables anyone intending to undertake excavation works to obtain information on the location of underground pipes and cables for any location within New Zealand, simply by making one single enquiry.

Power, Gas, Water and Telecommunications

All these services are provided via underground pipes and cables which provide a lifeline to both the business and private sector of this country.

Damaging these assets could affect thousands of businesses and inconvenience people across the nation. The cost of damages in repairs, downtime and loss of business could be unimaginable. But it does happen!

That's why using the beforeUdig service before excavation is vital to the well being of the entire community.

How Does beforeUdig Work?

Step 1

At least 2 clear working days before commencing your excavations, lodge a beforeUdig enquiry providing us with information about the worksite.

Step 2

Our state of the art system will immediately search its database to notify known asset owners who are members of the beforeUdig service and could be affected by the intended excavation works.

Simultaneously, we will send you contact details of these asset owners via a "Caller Confirmation" sheet.



Step 3

Participating asset owners will provide you with asset information relating to the worksite, usually within 2 working days of lodging your enquiry (allow 5 working days for response by post).

Whilst the most common response method is by providing you with a map of the site showing the asset locations, asset owners may choose to contact you directly to discuss the intended works or provide you with an onsite service to ensure the assets are protected.

Whilst it is free to use the beforeUdig service to gather information on the possible presence of underground assets in and around your proposed excavation site, to request plans and locate services, some Utilities and Local Government Organisations may charge to supply these services. Please check with the relevant asset owners listed on your confirmation sheet if you require more information on these possible charges.

The information supplied by beforeUdig of Asset Owners who may have underground assets in or around your proposed excavation site may not represent all Asset Owners affected. It is your sole responsibility to ascertain any other Asset Owners in or around your proposed excavation site. The information supplied by beforeUdig is solely to assist you in this process.
