

- Thank you for the opportunity to submit on the representation review, September 2024.
 This submission comments specifically on the role of Malvern Community Board and the proposal to disestablish the Board.
- The Community Boards Executive Committee (CBEC) is a sub-committee of the National Council of LGNZ. With a committee of community board representatives from each of LGNZ's geographical zones, a Te Maruata and a Young Elected Member representative. CBEC advocates for community boards across the motu and supports their development, capability and impact.
- Malvern Community Board reached out to CBEC and requested CBEC support during the representation review process.

Submission

- 4. CBEC notes the following major proposals in the consultation document:
- Reduce the number of councillors from 10 to eight.
- Maintain four wards with some boundary changes and rename the wards.
- No community boards.
- CBEC is concerned about the proposal to disestablish the last remaining community board in Selwyn District.
- 6. Selwyn is growing, fast. Over the last two decades, the Selwyn District has experienced rapid growth in population.¹ With this growth, there are inevitable new and diverse communities of interest that will likely emerge. This will likely take place beside the already established communities of interest, such as incorporated within the Malvern Ward/Board area. With a view to the future, SDC would be well placed to not only keep its last remaining board, but look towards how Community Boards could act as a vital tool in activating and realising localism.
- CBEC feels this growth pattern has not been thoroughly reflected in the proposal to disestablish community boards.

- 8. The demographic trends and spatial elements of growth, coupled with fast growth will be better harnessed and understood by giving appropriate value to local voice, through the use of community boards.
- We note that recently, Local Government NZ (LGNZ) published and distributed a WHIRIA TE HAPORI WHĀNUI LOCALISM: A PRACTICAL GUIDE. CBEC assumes, that like most Councils and Central Government, SDC has an interest in promoting and undertaking localism.
- 10. The toolkit highlights how Councils could be more effective, by presenting research conducted in 2024 by Curia. The conclusions for better effectiveness were:
 - > involving communities more when making decisions
 - > delegating more decisions to communities
 - > supporting community groups to deliver more services on behalf of councils
 - > strengthening their relationships with iwi, marae and Māori communities
 - > tailoring services more to the needs of local areas.2
- 11. By reducing Councillors to 8 from 10 and disestablishing your last remaining board, SDC risks losing a vital link to communities of interest and effective, fair representation.
- 12. CBEC encourages you to utilise Tool 10 in the Localism guide. This highlights how Community Boards play a vital role in "communities that have specific circumstances (such as a rural community in a predominantly urban council) that might mean their needs risk being overlooked by the governing body." Furthermore, "If local government bodies become larger, new avenues are needed for people to engage directly in the decisions that shape their future. When considering the role of community boards in achieving greater engagement in local decision making, this tool encourages councils to consider:
 - > what actions they can take to further empower and enhance the role of existing community boards (such as delegating decision-making responsibilities)
 - > whether establishing community boards or additional community boards would support the council to take a more localist approach to decision making.³
- 13. CBEC encourages consideration of localism and activating community voice. To achieve effective representation of communities of interest and fair representation of electors, Councils might be better placed to look at establishing more Boards, not disestablish them.

- 14. Due to the growth you are experiencing, and the very real urban/rural demographic, in addition to multiple distinct geographical communities of interest, we feel with no community boards and only 8 Councillors, it will be difficult to reach the level of local engagement required to reflect preferences.
- 15. CBEC appreciates the rationale and reasons for dropping to 8 Councillors, and views this as an opportunity for greater scope for Community Boards to deliver clear coherent views, from experts in distinct communities, to the governance table. Don't ask what value boards bring to council, ask how you can elevate your boards (or create a new board), to take decision making closer to the people, and let locals lead the charge. Boards are not an obstacle, they are an opportunity.
- 16. It is up to Councils to commit to a vision of authentic local democracy and empower existing Boards as a model for future Boards to be established as districts grow and become more diverse, rather than take the easy option of disestablishment.
- 17. CBEC considers the consultation document does not present a strong enough argument for the disestablishment of the Board. Other options for engaging with far flung communities such as Arthurs Pass and Castle Hill, could be tenuous. Communication systems can be unreliable, not all electors have access to vital communication systems and software and transport options are often limited in terms of making community meetings. If electors are unsure of what the potential role of the Board is and what it should deliver, then by working on better communications, and a functioning Board, settlements such as Arthurs Pass, will have a greater voice.
- 18. CBEC respectfully asks Selwyn District Council to reconsider your proposal to disestablish Malvern Community Board, in order to enable Council to let locals lead the charge. CBEC would like to see SDC retain their existing Community Board and look at how more Boards could be established to give greater weight to community voice while enabling 8 Councillors to be fantastic and effective governors.



Q1: Ward boundaries

I mostly do not agree with the ward boundary changes. West Melton should stay in Malvern. West Melton's community of interest is decidedly not with the Springs Ward. Ask any West Melton resident and I am sure there would be overwhelming agreement on this point. Just look at the geography and the main arterial roads. It makes no logical sense to put West Melton in the Springs Ward.

Let us remain steadfast and be sensible and logical and leave West Melton in Malvern. We should not bow to what I would politely suggest is managerial and political expediency in suggesting West Melton go to Springs Ward.

I do, however, agree that Burnham should become part of the Rolleston Ward. As new subdivisions are developed in Rolleston there is a growing merging of their respective housing areas. Therefore it is logical Burnham moves from Ellesmere to the Rolleston Ward.

Number of councillors

I do not agree with a reduction in the number of councillors. The Council should remain with ten. The Selwyn District is growing rapidly in population. I often read of the mayor lauding the fact that Selwyn is the fastest growing territorial authority in New Zealand. Therefore, our political representation should stay at ten.

I would suggest, however, a change in the mix.

Rolleston Ward to increase to four councillors and Ellesmere Ward to go down to one councillor. With Malvern and Springs Wards staying as they are, i.e. two and three respectively.

I acknowledge the population each councillor represents should be, by statute, within the range 9139.5 to 11170.5. However, the Local Electoral Act 2001 also makes provision for particular community of interest considerations. The Malvern Ward, due to its large geographic area and specific local issues, should thus be seen as a special case and not have to meet the population range criterion. The Council is also obliged to ensure councillors are accessible. The SDC's proposal of reducing Malvern Ward to one councillor hardly meets this obligation. The Malvern Ward, I submit, must retain its two councillors.

Q2: Malvern Community Board

I do not support the abolition of the Malvern Community Board. The Malvern Ward is a massive geographical area with many small and isolated communities. These communities are at some distance from our larger SDC towns. These communities need to be visited and talked to. Community Board members can do this. They are the hand-shakers in the fields and fairs, the listeners in the community halls. Community Board members are essential for gathering and then passing on local information to councillors.

To provide adequate local representation the Malvern Community Board must be retained (with at least three members).

Q3: Maori Ward names

I completely support the new ward names. The Maori language has been used in our area for around seven to eight hundred years (since circa 1240-1340 AD) so it is high time we acknowledged the tongue of the first settlers of this land.

Q4: Further comments

It will be another three or so years before another representation review is undertaken and then more time before any subsequent decision can be implemented. Let us look to the future and have adequate local body representation: to meet our needs now, and to meet our needs for the immediate years ahead.

The citizens of the Selwyn District Council must continue to be represented by ten councillors, no fewer.

Representation Review 2024

Having read the information provided in support of the recommended options for representation going forward, I have serious concerns in regard to "fair representation of electors" in the proposed Malvern and Ellesmere Wards.

Urban population in the major growth areas of Rolleston, Lincoln and Prebbleton will increasingly outweigh that of the proposed "rural" wards, so that the balance and significance of representation on Council of those "rural" wards, as proposed in the options, will continue to diminish.

Having been actively involved in Community Advisory Committees in Leeston in all forms for almost 50 years, I see advantages in 8 elected councillors acting along the lines of a board of directors, delegating appropriate tasks to elected Community Boards of eg 6 members representing constituent communities in both the proposed new Malvern and Ellesmere Wards. Any cost involved would be minimal and should be offset by the savings achieved by reducing the number of councillors from 10 to 8.

The **Community Boards** in "Rural Wards" would work with the elected local Councillors to enhance "rural ward" ratepayer representation and consultation, and also provide representative community imput on relevant issues. The dissolving of "Advisory Committees" in those areas in particular and their direct links to the Council on the grounds of administrative costs was detrimental to good governance principles and "fair representation".


