#### RECOMMENDATION

#### **SAFE SYSTEMS**

#### Safe Speeds

**safe speeds** that suit the function and level of safety of the road - road users understand and comply with speed limits and drive to the conditions.



**Rural Speed/Loss of Control**: We have not confirmed what the Police speed campaign will be this year. We will arrange a media release for the Holiday driving period in early December. Some print advertising will be planned for January prior to the return to school campaign.

#### **Safe Vehicles**

**safe vehicles** that help prevent crashes and protect road users from crash forces that cause death and serious injury.



**Safe Vehicles**: Supported by Driving Instructors and workshops in the Young Driver programme and in the Mature Drivers courses.

## Safe Roads & Roadsides

**safe roads and roadsides** that are predictable and forgiving of mistakes - their design should encourage appropriate road user behavior and safe speeds.



Intersections: A campaign will be prepared and delivered during March and April 2018. We will be looking to to link with Police and an enforcement component for the campaign.

#### Safe Road Use

**safe road use** ensuring that road users are skilled and competent, alert and unimpaired, and that people comply with road rules, choose safer vehicles, take steps to improve safety and demand safety improvements.



**Drink Driving:** The annual drink drive campaign will commence on 27 November and will continue until the second week of 2018. New design print advertising, bar mats and posters and other resources will be developed and produced for the campaign. The new billboards will be installed on our local roads and also displayed until mid January.

The main focus of this campaign is the supporting our licensed premises throughout Selwyn to promote courtesy vans and other safe options for travel home. However, we will also develop a community engagement activity to increase awareness, of planning a safe ride home and looking out for others during the busy pre-Christmas season, with increasing number of work and social activities.

Motorcycles: The annual Kick Start motorcycle event was held on Sunday, 01 October. This is a collaborative project with Christchurch City Council, Waimakariri District Council, Police ACC and motorcycle trainers. The event was hugely successful with excellent feedback received following the event. We are also supporting motorcycle safety with twenty free motorcycle training places on Ride Forever courses for Selwyn residents.

**Mature Drivers:** Age Concern continue to deliver the Mature Drivers Courses for Selwyn District Council. Drivers that are able to attend are generally over 65 years. The first one was held in Lincoln on 03 November with 18 people attending and the next is in Darfield on 21 November.

**Fatigue:** Print advertising reminding drivers about fatigue. Water bottles with fatigue messaging on the labels have been developed. These are being distributed at Council events and activities. The Police will also be distributing these prior to show weekend. These messages will target drivers, who because of the warmer months, plan long weekend breaks that may result in longer periods behind the wheel than usual. The key message is "Drivesmart" by sharing the driving, keep hydrated and take a break from driving every two hours.

**Young Drivers:** We held one Leading Learners course on 5<sup>th</sup> Of October with good feedback from both young drivers and parents.

The Community Young Driver Mentor Programme continues with good progress being made by all participants.

Two vehicle maintenance workshops were held for young drivers and their parents in October. Twenty five people attended the two nights. We gratefully aclnowledge Jones Road Auto and Selwyn Auto for their support with these. The feedback received has been very positive and we will look at running more of these in the future.

**Distraction:** The Drive Phone Free distraction campaign commence of 18 September16 October. The target was drivers who continue to choose to

use hand held phones while driving and encouraging others to also speak up of the risks of not Driving Phone Free.

Print advertising, posters and resources will be distributed during the campaign. This year a Facebook component was added to the campaign to encourage community engagement in the campaign. We added a post to the SDC Facebook page once a week for 4 weeks and offered a chance in a prize draw each week. Abrief summary of engagemet is noted as;

Week 1:559 Reactions, 65 Likes, 473 Comments

Week 2:138 Reactions, 25 Likes, 112 Comments

Week 3:173 Reactions, 34 Likes, 132 Comments

Week 4:87 Reactions, 11 Likes, 75 comments


#### **Community Road Safety Fund:**

#### **School Safety:**

20K Either Way launched at the start of Term 4 with print advertising, posters and social media. Media Release picked up by local papers and radio.



Actively working with Rolleston College, Rolleston Christian School, West Rolleston Primary, Lemonwood Grove, Weedons School, Lincoln Primary and Lincoln High School to develop their School Travel Plans. Interest in travel planning has also been shown by Broadfields and Ladbrooks.

Working with West Melton School with the construction of their Kea Crossing. Crossing will be operational in Term 1 2018. Trialling new

iniatitive 'Safe Meet Spot' to reduce congestion on Weedons Ross. Will continue to evaluate in Term 1 once construction is complete.

The inaugural Road Patroller end of year appreciation celebration was held on Saturday 11 November at the SAC. 152 patrollers attended for 2 hours of pool time with awards and a Sausage Sizzle after supplied by Blue Light.



Promotion internally of Aotearoa Mini Cycle Challenge for October, poor uptake.

Ongoing planning for Summer Active Transport Campaign and Cycle Skills Pilot.

**Child Restraint activities:** Currently trialing fortnightly check sessions to reduce pressure on individual technicians. Ongoing support of technicians with supply of carseat clips and anchor bolts as required.

**SeatSmart:** The SeatSmart car seat recycling initiative has been deemed a successful trial with 62 seats recycled to date.

## **Road Safety Programmes**

#### Ngaire:

Six "High Fit" Activities at a cost of \$192,000/annum (Subsidised)

- Impaired Driving (Alcohol)
- Intersections
- Motorcycles
- Speed/Loss of Control
- Young Drivers (16-24 yrs)
- Mature Drivers (65+ years)

Three "Medium Fit" Activities at a cost of \$28,000/annum (Subsidised)

- Distraction
- Fatigue
- Safety Belts


- Safer School Journeys cost \$13,000/annum (Non Subsidised)
- Travel Demand Management cost \$36,000/annum (Subsidised hopefully) => Greater Christchurch TDM Business Case
- Continues with further funding established for 2017/18 relating to cycling programmes (but subsidised)
- Undertakes The School Road Safety Program:
  - ✓ Liaises with Schools through the School Travel Plan Process
  - ✓ Encourages active transport modes
  - ✓ Undertakes campaigns around pertinent school road safety issues
  - Cycle programmes e.g. Aotea



### Minor (safety) Improvements

- Now referred to as Low Cost/Low Risk improvements are those that fall under \$1 million dollars each.
- Average cost of programme \$548,000 per year (about what it has been to date)
- Our Low Cost/Low Risk program includes any eligible roundabouts, seal widenings, intersection
  upgrades and bridge replacements.
- Have developed a targeted program that addresses safety issues based on historical traffic and crash data.
- Where applicable, intersection improvements to align with adjacent unsubsidised seal widening projects.
- These improvements will increase the safety of all road users.

#### **Proposed Seal Widening Projects**




Historically, seal widening projects have resulted in safety improvements for drivers, predominately related around intersections when this has been included in the works. This is in conjunction with the other improvements obtained from widening such as reducing maintenance demands from seal edge break and the less tangible safety issues associated with a narrower carriageway that pushes opposing traffic closer together, plus more risky passing maneuverers and road run off. With the significant increase of heavy vehicles on our rural network these issues have become more evident.

For example, the Lincoln Rolleston/Selwyn Road and Springston Rolleston Road links were upgraded roughly eight years ago as Rolleston's the southern arterial link to Christchurch and to Lincoln respectively.

"Before Seal Widening" shows the number of crashes on these two links before seal widening. (These links are coloured in green).

N.B. There were a total of 40 crashes, 28 which occurred since the year 2000.

#### **Before Seal Widening**




<sup>&</sup>quot;After Seal Widening" shows the number of crashes on these two links after seal widening.

The number of crashes have stayed in around 30 despite traffic volumes on these two links increasing between 10 and 14 times.

This suggest the seal widening upgrades have been successful at improving road safety by reducing the crash risk along these two links.

This is part of the rationale behind the proposed seal widening projects put up in the 2018-28 LTP and capitalises on the endorsement of these in recent NZTA business cases as part of the package of state highway and local road relating to SH1, and SH73 which will attract subsidised funding

#### **After Seal Widening**



Concurrently, Council staff are using evidence to inform how Low Cost/Low Risk funding is prioritised.

The screenshot from Council's RAMM GIS platform has been used to layer our evidence base. This provides the "safety context" for intersections in the District and informs our prioritisation process.

The layers consist of:

- Number of Intersection crashes since 2008 (Purple circle with number)
- Deficiency Database sites (Blue Dot)
- Minor Improvement Database sites (Green Dot)
- % Growth in Heavy Vehicles since 2010. (Coloured Lines)

This information will be analysed and used to prioritise our Low Cost/Low Risk Forward Works Program.
