REPORTS

The Mayor acknowledged the impact of Cyclone Gabrielle on some councils in the North Island. He thanked Councillor Dean in helping Council to work with Selwyn Sounds to collect money at the gate on Saturday and for the generous support of the community. He also thanked all Councillors and staff who were there on Saturday and said it was a great effort. The Mayor connected each school in Selwyn with a school in Gisborne.

1. Chief Executive

Chief Executive's Report

The Chief Executive briefly went through his report. ECan biodiversity advisory group – Councillor Mugford was our representative and my recommendation is for him to continue. Similarly, Councillor Miller be appointed as the representative to the Summit Road Protection Authority.

The Chief Executive said that Council recently hosted visitors from two Pacific Island councils, namely Honiara City Council in the Solomon Islands and Suva City Council in Fiji.

He also acknowledged the Mayor for chairing the recent 2 day Local Government Rural and Provincial meetings held in Wellington. Councillors who also attended shared their experiences. Councillor Miller said on the positive side it was good to see the role that LGNZ can provide in disaster situations

Councillor Gliddon added the cyclone damage would probably take years to rebuild. She also noticed that on Greater Wellington Regional Council's flood protection plan, Selwyn was missing from the plan and would question why considering it is a flood prone district.

Councillor Epiha asked about other areas that Council staff were supporting and the Chief Executive said up to 17 staff and volunteers were already spread around. He was constantly in touch with other councils through LGNZ about who needs what support.

Councillor McInnes noted it was International Women's Day and said the theme was 'Embrace Equity' – and this goes beyond only women but includes everyone.

Private Plan Change 80 – Rezoning of Land in Rolleston

Councillor Miller asked about water consents being transferred according to a Council policy and Councillor McInnes asked about any issue around works already planned.

Councillor Hasson left the Chambers.

Staff noted there were already specific conditions added ensuring that no development takes place until the necessary roading and other upgrades have been undertaken.

Staff also said that landscaping was usually done before any development.

- c. delegates to the Head of Strategy and Policy to take any steps necessary to give effect to the recommendation in (a) and (b) above; and

d. delegates to the Head of Strategy and Policy to take any steps necessary to give effect to making Plan Change 80 operative at the conclusion of the appeal period where no appeals are filed.'
