# Roger Crozier: Darfield Sewerage and land on Creyke Road

Mr Crozier handed out a three page document, noting it showed the timeline of the issue, a handout from a public meeting and layout of the subdivision he developed.

He said as a result of the proposed Sewage Treatment Plant on Creyke Road he had suffered great loss on his sections. He believes an injustice was done to developers and they were struggling to sell. Mr Crozier said that once lawyers find out about the proposed scheme, they advise potential buyers not to go through with a purchase. He said he thinks it was a mistake to want to put the plant on the identified land.

Mr Crozier added he has good relationships with staff involved. Councillor Miller asked what Mr Crozier's ideal outcome would be to which he responded the plant should go ahead, but potentially elsewhere.

The Mayor thanked Mr Crozier for attending and asked that Item 7 be presented in order that Mr Crozier can be part of the conversation (*refer Item 7 minuted chronologically*). He added it may be that the discussion held in public forum could provide direction to the matter.

He said the process had not been good for residents as Environment Canterbury notified the consent application with limited notification, allowing objections from people within 500 metres of the site. The Mayor's letter asked that Environment Canterbury give serious consideration to full notification instead.

The Mayor also thanked Councillors involved and said he also spoke to the Christchurch City Council Mayor about the matter. All of the information will be available on Environment Canterbury and SDC's websites.

# 7. Asset Manager Water Services

Darfield and Kirwee Wastewater Business Case Assessment

This item was taken directly after public forum but for clarity will be minuted in chronological order.

The Group Manager Infrastructure and Asset Manager Water Services presented the report on the Darfield and Kirwee Wastewater Business Case Assessment. It was noted the graphs depicting responses were split – residential and commercial. The latter seemed to trend more towards the positive. The Asset Manager Water Services said it had been a long journey with many reports and he would be keen to get direction about which way Council wanted to go with the issue. He added the responses showed a good representation of people and that meetings were well attended. In response to a question as to what 'central' (refer rec (b)) meant, he said that the feedback from business owners said their businesses relied on sustainable long term options, with the concern that if it failed there would be negative consequences for their business.

The Mayor suggested an amended around reviewing an option for location and treatment, including piping to ESSS.

# Comments from Councillors included:

- Councillor Lyall thanked staff for a good report and said 22 years was a long time. He said with Darfield's growth the lack of options should now be taken care of.
- Councillor Hasson thanked staff for the report noting Darfield had high nitrate levels and that there was uncertainty around where it was coming from.
- Councillor Alexander noted it seemed that the price people were willing to pay was
  less than what it would actually cost. He also said it seemed current residents wouldn't
  have to hook into the scheme although businesses and new residential properties
  would have to. He added the Rolleston Community were given 7 years to hook into
  the plant, yet this was taking so long.
- Staff noted that buying up a block of land to put up a scheme could be challenging and costly.
- Councillor Miller said it was logical to do the main street first, then take one street a
  year and just tick away at it until it's all hooked up. He said this was exactly why the
  District Wide Rate was put forward but it wasn't happening fast enough. He added
  Council was not doing its communities and businesses a favour.
- Councillor McInnes said she agreed that existing properties should have a treatment option as well and said another issue was how one would deal with those old tanks.
- Councillor Mugford said he had been involved in this for 12 years and he said it was time Council was brave and make a decision. He said he often heard people noting that they would move to Darfield if only there were smaller sections available. If one took the money out of it, people would unanimously want sewerage options in Darfield.
- Councillor Lemon said it was Council's job to be brave. He said Council was not helping the community by not doing anything.
- Councillor Bland said Darfield was the biggest community in the country still running on its own septic tanks. He added a cost analysis would be helpful of how much it would be if the Creyke Road site was run efficiently. He added it would be a mistake to do a little bit now and then more later. He thought Council should commit to doing everything at once.
- Councillor Lemon said the Audit and Risk Subcommittee would look at the Pines
  facility and the impact of tradewaste. He asked staff to assist the Subcommittee in
  getting a better understanding of what that might mean in terms of capacity.
- The Mayor told staff that Council needed to make the right decision. He said the Group Manager Communication and Customer Services would also get messages out to the community to understand clearly what the options are, including and especially around costs.

- b) Endorse the recommendation from the Darfield Business Case assessment that there is sufficient evidence to support planning toward a potential central Darfield Wastewater Scheme, and

- c) Request staff to prepare a brief statement to include in the 2020/21 Annual Plan consultation document to further engage the communities desire for a reticulated wastewater system within central Darfield and for any new development within the township; and indicating that formal consultation on any proposal would take place as part of the 2021 -2031 Long Term Plan Process.
- d) Continue to strive for cost effective and environmentally sound solutions that could ultimately benefit the whole Darfield and Kirwee communities in the future; and
- e) Review options for the location and treatment including piping to ESSS.'
