#### 6. Group Manager Communication and Customers

Long-term Plan 2021-2031 Consultation Document

The Long Term Plan project manager, Mr Bell, briefed Council on the audit process which has now been complete. He read the audit opinion as follows:

'In our opinion:

• the consultation document provides an effective basis for public participation in the Council's decisions about the proposed content of its 2021-31 long-term plan, because it:

- fairly represents the matters proposed for inclusion in the long-term plan; and
- identifies and explains the main issues and choices facing the Council and Selwyn District, and the consequences of those choices; and
- the information and assumptions underlying the information in the consultation document are reasonable.'

Mr Bell then went on to say that the opinion also includes an emphasis of matter in relation to the uncertainty created by the Government's intention to reform the three water services. This is a cross sector matter and not something within the control of this council. He added the audit opinion is an important statement as it provides assurance to the Council and community that the consultation document is a suitable basis for consultation on the long-term plan.

In response to a question as to when the consultation document would be available staff noted there would be a limited number printed in-house and also an electronic copy on the Council website later this day.

Councillors congratulated the team for the hard work.
