There was general discussion about the volunteer work undertaken in McHughs forest park which has dwindled since the opening of the park and also the conflict on the tracks through the park e.g. pedestrians on the bike track and vice versa.

Action Point

5. Chief Executive

Manager's Report – March 2021

The Chief Executive's report was taken as read.

Council's Group Manager Property, Mr Marshall updated the Board as follows:

- Springfield Township Committee letter (19 March 2021) response to Township Committee questions from MCB meeting 8 March 2021.
- Outline of development of some basic community tracks through the provision by a contractor of a digger and time for this development and working with parents in a community which provides a facility for little cost. Ongoing issue of maintenance of these tracks when not used for long periods of time is an issue.
- Castel Hill wilding tree removal project outlined development to date but work in progress. Letter that is going to all Castle Hill residents to be circulated also to MCB.

Councillor Gallagher raised an issue with the 'Give Way' intersection at the corner of Aylesbury/Bealey Roads (SH73) and that she had had discussions with Council's Asset Manager Transportation (*Andrew Mazey*) and whether it was a Council or NZTA issue. General discussion followed on how dangerous this corner is.

The Community Board are prepared to pay for the advertising for the registrations of interest.

GENERAL BUSINESS

1. Sheffield Water Supply

Mr Woods advised he had become aware of an area of land approximately 10ha in size in Sheffield that was zoned residential and that this area of land perhaps does not have a water supply allocation. He was of the view that the provision for water supply is either inadequate or the township supply is capable of supplying a larger area than is known.

This is also a similar situation in Waddington. The question about the ability of Sheffield water supply to take on additional connections was raised.

"That the Malvern Community Board receive a formal update at its April meeting as to the state of the water supply in Sheffield and the upgrade and its ability to supply additional water resources to new sections/developments with a view to making a submission to the Council's Long Term Plan should it be necessary."

2. Submission to Environment Canterbury Long Term Plan

Following the presentation to the Board prior to the meeting by Environment Canterbury Councillors, the Group Manager Property suggested that the Board take some time now to form a submission. The following issues formed the basis of the submission:

- Support the capacity to increase the UAGC (Uniform Annual General Charge) therefore
 the burden becomes more on the householder rather than capital value i.e. the fixed
 sum is allocated to all rateable properties equally.
- The UAGC should be based on services provided to be distributed equally among all rateable properties.
- Do not support Ecan borrowing for operational projects but supports the borrowing for capital projects and intergenerational projects.
- Concern for the level of rate increase therefore lower priority projects could be axed therefore the rate increase doesn't need to be so high.
- Ecan should submit to the Government about supporting projects that have already been undertaken to the benefit of the region.
- Supports the regional review of co-joining with other Environmental bodies.
- Supports the continuation of the Darfield bus service.
- Supports the comment on pest management in particular the removal of wilding pines in the Torlesse Basin and Coleridge Basin.
- Supports the level of river protection within the Ecan/Selwyn catchments.
- Enviro Waste in Schools Ecan should be funding their own core business and NOT Central Government initiatives.

It was agreed that the Group Manager Property would draft the submission based on the points raised by the Board and forward it to Board for their final approval.

The Board requested that the Council's submission to the Ecan Long Term Plan be forwarded to the Board in case there is anything in the Council submission the Community Board wants to support.

Mrs Pascoe asked if she could identify the points raised at the meeting for the Malvern News article. This was **agreed** to.
