PUBLIC FORUM

Four representatives from the Malvern Housing Trust were present to talk to the Board about the management of three houses on North Terrace in Darfield. They referred to a report from Council staff on social housing, dated October 2018. In response to questions from the Board, the representatives noted they would be able to maintain the properties and that they would be looking to do more than mere property management. They would include wrap around services to tenants. The group said they were currently putting together a formal proposal but wanted the Board's input before going to Council. They felt it was crucial that they work with the Board and also that Council was made aware that they had been in contact with the Board.

The Board told the group that they unanimously agree to support, in principle, their proposal and that they would share any information on the topic with the group. The Malvern Housing Trust agreed to do the same.
