CONFLICTS OF INTEREST

HEALTH AND SAFETY PRESENTATION

The People and Capability Manager presented the Board with information related to the use of an Automated External Defibrillator (AED). He noted that five people a day suffer from sudden cardiac arrest and of those only 6% had access to an AED. He advised Board Members to load an app on their phones which showed where there were AEDs in relation to your proximity. He also told the Board that the number of New Zealanders dying of cardiac arrest was 5 times the road toll and with an AED, up to 90% could have a chance of survival if it was applied within 10 minutes. Longer than 10 minutes and that chance dropped to between 7-10%.

A brief demonstration of how the AED works, as well as a short video concluded his presentation.

The Chair thanked the People and Capability Manager for the presentation on the use of a defibrillator.
