PURPOSE

The purpose of this report is to provide information to assist with the decision to recommend a grant.

2. SIGNIFICANCE ASSESSMENT/COMPLIANCE STATEMENT

No significance issues identified.

3. HISTORY/BACKGROUND

Brooke Bennett resides in the Selwyn Central Ward.

She has been selected as a member of the New Zealand Swimming Programme Team.

To achieve selection swimmers must reach certain target times. Brooke at fourteen years old is one of the youngest of seventy five from throughout New Zealand to qualify and is the only one from Selwyn District.

Normally being named in this team would mean travelling to Australia to compete in their state championships. Covid-19 has meant no travelling is allowed so the trip has been replaced with national camps.

Brooke is attending two camps, however she is only seeking funding to attend a camp to be held in Auckland from 27-30 January 2021.

The cost to attend is \$1,213.00 including airfares, accommodation and other sundry costs.

Brooke has received sponsorship from Swimming NZ and her parents are holding a raffle. It is hoped to raise \$275.00.

A grant of \$600.00 is sought.

4. PROPOSAL

The standard grant for individuals is \$500.00.

A grant of \$500.00 is therefore recommended.

Brooke's parents will meet any remaining balance.
