#### **INTRODUCTION**

These Terms of Reference exist for the following Committees and Community Board:

- Selwyn Central Ward Discretionary Fund Committee
- Springs / Ellesmere Ward Discretionary Fund Committee
- Malvern Community Board

As part of the Terms of Reference, the following requirements will be adhered to:

- each Ward Discretionary Fund Committee will elect a Chair and Deputy Chair
- the Ward Discretionary Fund Committees shall be a Committee of Council, established by Council
- the existence of these Committees does not remove from Council, any of its legal obligations or responsibilities
- the quorum will be no less than two members
- meetings shall be held at a date and time at the agreed by each of the Ward Discretionary Fund Chairs at agenda preparation time

#### **PURPOSE**

Selwyn District Council provides funding at a Ward level to support groups and individuals whose projects contribute to the strengthening of community wellbeing in Selwyn and the achievement of Council and community board policies, strategies and priorities. By developing and enriching themselves, individuals in turn can contribute to community wellbeing.

#### **ADMINISTRATION**

#### **PURPOSE**

The report is prepared for the purpose of directing members to the existing ward discretionary funding policy, with a view to giving consideration to the future purpose of the discretionary fund allocation.

Attached to this report is a copy of the Funding Policy and Guidelines for the Springs and Ellesmere Discretionary Funds Committee. When reading this attachment please note that it has been uplifted from the Selwyn District council website and following today's discussion will be updated to reflect current dates and available finance.

#### **HISTORY / BACKGROUND**

On an annual basis, Council identifies a sum of money to be allocated by Ward Councillors for activities undertaken within rrespective electoral areas. The funds available for the remainder of the financial year are as follows:

Malvern	\$14,594
Springs	\$23,976
Ellesmere	\$15,637
Selwyn Central	\$30,231
Total Ward Funds	\$84,438

In early 2017 representatives from all wards responsible for allocation, together with the Malvern Community Board, discussed and reviewed the funding policy and guidelines which existed at the time. The purpose was to streamline the process of advertising, compilation of applications, and formalising the meeting procedures in accordance with the LGOIMA.

Currently each of the respective wards have a similar view to the administration process and allocation of discretionary funds. It is my view that the process currently in place is appropriate.

## SELWYN DISTRICT COUNCIL WARD DISCRETIONARY FUND FUNDING POLICY AND GUIDELINES

#### 1. Purpose

Selwyn District Council provides funding at a ward level to support groups and individuals whose projects contribute to the strengthening of community wellbeing in Selwyn and the achievement of Council and community board policies, strategies and priorities. By developing and enriching themselves, individuals in turn can contribute to community wellbeing.

#### 2. Governance and Administration

All applications for the Selwyn District Council Ward Discretionary Funds are forwarded to Council's Accounting Officer who will prepare a report for consideration by Ward Councillors or the Malvern Community Board.

These funds are dispersed by the Malvern Community Board (for Malvern ward), and Ward Councillors for Selwyn Central and Springs/Ellesmere.

#### 3. Budget

There is an annual budget established by Council for dispersal for each of the four Wards. Whilst the amount varies annually, the total fund available for 2018 / 2019 is \$81,000 with the Ward breakdown as follows:

 \$14,000
 Selwyn Central
 \$29,000

 Springs
 \$23,000
 Ellesmere
 \$15,000

#### 4. Funding Guidelines

It is acknowledged that this is a discretionary fund and should be treated as such by the respective Governance groups when they are considering the merit of each application.

It is considered prudent however to be able to give some advice to Selwyn residents or non-profit community organisations based in or working in Selwyn and delivering services/activities in Selwyn on the types of applications to the Fund which will be considered. These areas include:

- Community groups based in or working for Selwyn District, which are providing community, social, recreation, sporting or arts projects or activities in the District.
- Personal growth and development for individuals who are contributing to community wellbeing in Selwyn
- Capacity building and development for Selwyn-based community organisations
- Representation at events individuals:
  - Applicants selected to represent their school, team or community at a local, regional, national or international event or competition this can include sporting, cultural or community events.

- Representation at events teams:
  - As above, but teams are required to submit only one application on behalf of the team members resident in Selwyn District requiring funding assistance
  - o Residential addresses of team members must be supplied.
- Seed funding for special events or projects (e.g. equipment, promotion, venue hire, setting up a new sports team or activity).
- School projects which are outside of Ministry of Education curriculum activities.
- Church programmes/activities which include the wider community (e.g. preschool programmes, parenting programmes).

#### **Terms and Conditions**

- 1. Grant applications are limited to projects or activities within the Ward area or primarily benefiting the residents of the Ward
- 2. Applications from community organisations are required to submit a balance sheet and an income and expenditure statement which shows current financial assets and liabilities. In most cases, applications will not be processed until financial information has been received.
- 3. Applicants cannot apply in consecutive years as a right, however each application will be considered on a case-by-case basis.
- 4. Applicants should demonstrate their efforts/ability to seek other sources of funding and not rely solely on Council support.
- 5. Applicants need to provide evidence of fundraising, unless they can cite reasons for financial hardship. Applicants must also explain how they will cover any funding shortfalls.
- 6. If three (3) or more persons apply individually for funding for a team event, the applications will no longer be considered as individual; but instead will be considered on a team basis.

#### **Accountability**

- 1. Funding must be spent within a 12 month period from the date of allocation.
- 2. Funding must be spent on the purpose for which it was allocated.
- 3. Any unspent funds must be returned to the Council.

Darci Brostow resides in the Ellesmere Ward.

She has qualified to compete in the Pairs Female division of the Torian Pro Finals to be held in Brisbane from 6-11 November 2019.

The competition involves undertaking exercises, known as crossfit with movements increasing in difficulty as the workouts progress.

Crossfit is designed for people of all backgrounds, ages, skill and fitness levels. It combines elements of weightlifting, gymnastics, functional movements and cardio to improve health and fitness.

Qualification was undertaken through submission of a performance video. The top thirty two teams qualified to attend the competition.

The cost to attend is \$2,116.92.00 which includes airfares, accommodation, transport and entry fees.

Time constraints have meant no fundraising has been able to be undertaken.

A grant of \$500.00 is sought.

#### 6. PROPOSAL

Staff believe a grant should be supported as the trip will benefit Darci's personal development and improve her crossfit skills.

The standard grant for individuals is \$500.00.

Staff recommend a grant of \$500.00 be approved.

This report is to assist with the decision making process for this application.

#### 3. SIGNIFICANCE ASSESSMENT/COMPLIANCE STATEMENT

#### 4. HISTORY/BACKGROUND

The Pioneers of Canterbury Masters Marching Team will be attending the New Zealand Marching Championships, to be held in Auckland from 23-29 March 2020, to compete in the masters division.

To be eligible to attend the national championships the team will compete in the South Island Marching Championships to be held on 15 December 2019.

The team comprises twenty six members, eight of whom reside in Selwyn District

Three reside in Selwyn Central Ward, three in Springs Ward, one in Ellesmere Ward and one in Malvern Ward.

The total cost for the team to attend is estimated to be \$18,160.00. This includes airfares, transport, accommodation, entry fee and food.

Team fundraising has been undertaken through a show involving a hypnotist raising \$3,500.00.

A grant of \$3,021.00 is sought.

Team members will meet the balance of costs.

The standard grant for applications involving teams of three or more is \$1,500.00.

Based on the eight members resident in Selwyn District members this works out at \$188.00 per member.

Staff therefore recommend a grant of \$564.00 from the Selwyn Central Ward Discretionary Fund for three members, \$564.00 from the Springs Ward Discretionary Fund for three members, \$188.00 from the Ellesmere Ward Discretionary Fund for one member and \$188.00 from the Malvern Ward Discretionary fund for one member.

A report recommending this will be considered by the Selwyn Central Discretionary Funds Committee at its meeting on 20 November 2019 and the Malvern Community Board on 25 November 2019.

#### 5. HISTORY/BACKGROUND

The Lincoln High School Mixed Touch Team is to participate in the New Zealand Secondary Schools National Touch Tournament to be held in Rotorua from 12-15 December 2019.

Seventeen pupils and two adults will be attending.

No qualification process was required as NZ Touch have changed the rules to allow open entry via ballot for teams outside the top twenty from 2018. As Lincoln High school had finished second in 2018 the team qualified automatically.

The estimated total cost to attend is \$13,673.00 comprising return flights, accommodation, meals and other sundry costs.

Of the eighteen pupils in the team, seventeen reside in Selwyn District and one in Christchurch City.

Thirteen are resident in the Springs Ward and four in the Selwyn Central Ward.

The pupils involved have been undertaking fundraising involving a quiz night, car parking and obtaining sponsorship. It is estimated \$3,200.00 will be raised

The balance of costs will be met by the families of team members.

#### 6. PROPOSAL

The standard grant for teams of three or more is \$1,500.00.

Staff support a grant being made as it will assist in the personal development of the pupils concerned and help them extend their sporting ability. A grant of \$88.00 per pupil is supported by staff based on seventeen members.

A grant of \$1,144.00 from the Springs Ward Discretionary Fund is therefore recommended.

The Selwyn Central Discretionary Funds Committee will consider this application with the same recommendation (\$88 per pupil) at its meeting on 20 November.

A grant of \$535.00 was approved in November 2017 for five team members to attend the 2017 tournament.
