Submission to the Selwyn District Council

We, like the majority of farmers in the Selwyn district already pay 43% of our annual rates to fund the current water race system.

We think the council needs to look at the cost and the proposed increase in providing that service

over the next 10 years.

Like so many farmers in the area we do not use the water races for stock water anymore. It costs us to clean and fence the water races, not to mention the extra \$70,000 recently spent when the water race committee did not allow us to move a water race within our property. This cost was caused by having to add a variable rate system to our pivot and associated wheel crossing costs.

We would like the council to look very closely at continuing to run a water race system in the Selwyn area as we now live in a totally different age as to what they were designed for. The council now provides water schemes and also there are a large number of water wells so there is not the need going forward for water races to provide water for stock and as was once the case for house

We are opposed to a continuation of the proposed significant rating cost of water races if it is rolled over as seems to happen and no longer see a need for a water race system in the Selwyn District. If the council considers races need to remain to service the community and the environment then they should be rated accordingly.

RE: Long Term Plan 2018-2028 Consultation

The Coleridge Habitat Enhancement Trust (CHET) comprises trustee representatives from DOC, Forest & Bird, Fish & Game, Coleridge Farm Representatives, Trustpower Ltd and Selwyn District Council (SDC). CHET's Chairperson is currently SDC Councillor Bob Mugford.

CHET was established to provide a means of mitigating some of those environmental effects that could not be anticipated or provided for during the Coleridge Hydro Electric Power Station consenting process. The Trust aims to identify ways to enhance, maintain or create freshwater habitats within the Lake Coleridge catchment.

The trustees are aware that the district's growing population, tourist numbers and increasingly intensive farming activity is all putting pressure on Selwyn's unique wild environments. We believe that what remains of the district's unique natural biodiversity needs more protection to ensure no further degradation of habitats that native plant and animal species rely on for survival. We believe that protecting and restoring the district's natural areas will be of great value to residents well into the future.

In considering the Selwyn District's Long Term Plan 2018-2028, CHET would like the Council to adequately provide for the following:

- Better management of freedom camping through clear and readily accessible public
 information, good facilities in appropriate places, more maintenance of existing assets, and
 enforcement of the rules to minimise damage and degradation of the district's scenic
 recreational areas. We would also like to see more proactive support for landowners who are
 voluntarily providing public access and/or facilities in scenic areas.
- Funding allocated to do more work to monitor, measure and support what remains of the district's unique environments and biodiversity for use by the Council and other groups (eg. to support the Predator Free 2050 goal for New Zealand).

• Ensuring the protection of remaining natural habitats is prioritised in all development decisions and sustainable development options are encouraged.

The SDC Full Draft Long Term Plan 2018-2028 'Community Facilities Activity' section, page 9, notes: "There has been increasing awareness of the fragile state of the nation's biodiversity and the need to take action to conserve and protect it from further degradation."

We are pleased that the issue is recognised here and in other sections of the Draft Long Term Plan but feel that the Council should make a stronger stand and give more priority to protecting and restoring the district's unique biodiversity and wild areas.

Overall outcome sought:

In conclusion, CHET would like SDC to ensure adequate resourcing of biodiversity and support staff to ensure Selwyn's unique wild areas are protected.

Executive Summary

The Council has proposed in the Long-Term Plan 2018–2028 the construction of a new Community Centre in Leeston in 2025/26 at a cost of \$6 million.

The submission from the Ellesmere Heritage Park is that this build proposal be given a higher priority in the District Plan and that the construction of the new Community Centre be on site which contains the Ellesmere Heritage Park and adjoins the Ellesmere A&P Association.

The Ellesmere Heritage Park fully supports the Draft 2018 Walking and Cycling Strategy as detailed which proposes seven major new cycleways across Selwyn and the Lincoln to Tai Tapu cycleway improvements.

The opportunity to bring together community, arts, culture, recreational supporting facilities and activities, is indeed, enticing. Alignment of the past with modern living, considered in combination, promises to provide that which might otherwise be currently missing from the community. Further focus might well be on promoting Ellesmere and it's surrounds as a tourist destination and as a key component of a road and cycling network linking with heritage, cycling and tourist trails to be advanced as part of a regional and nation-wide network.

Locating the proposed Leeston Community Centre in the vicinity of the Heritage Centre grounds will provide community and geographic cohesion, encapsulating, in a positive manner, the town within. A community centre at this location would connect the showgrounds, dog park and Heritage Centre & Cultural Park as a community hub at the opposite end of the High Street from the Leeston Park, Skate Park, Hotel and Rugby Club. This could serve to generate higher pedestrian and cycle traffic flow along the high street (from community space to evening entertainment space) and therefore better commercial prospects.

Grouping these elements also serves to provide greater relevance to the individual entities and a more interesting social space for Tourists and locals alike. Ellesmere has stories to tell. New Zealand tourism is on the rise (rapidly). This has the potential to expand tourist opportunities for Day Trips to the Leeston Area by Retirement Homes etc and the wider public and tourists to New Zealand.

Those that travel the main highways slicing through rural Canterbury miss the opportunity to learn from and enjoy the rural countryside and special flavour of small-town New Zealand.

NZ is poised to enjoy unprecedented tourism growth and numbers of visitors to our country. Tourism into NZ has changed markedly of late. Leeston, Ellesmere and the wider Selwyn District could do with their share of domestic and international tourism that they are currently, largely missing out on.

NZ off the main highways has become, and will increasingly be, the place to visit. Scenery and environment has always been our point of difference. Selwyn District has a great opportunity to link with adjoining areas, welcome these tourists, provide for the required infrastructure and broaden the range of attractions available.

Enhanced facilities and services for locals, developed with an awareness of what is needed to include Ellesmere and Selwyn on the cultural and heritage trails being developed from Banks Peninsula to Mid Canterbury and Central Otago, will be of social and economic benefit to towns and villages along the way.

The vision and opportunity of bringing millions of tourists off the beaten track to small town New Zealand and to showcase to others the great countryside we often take for granted, is there for grasping. From heritage to culture we are a unique collection of places and experiences, worth sharing with others and enjoying ourselves.

The opportunities to Selwyn District are endless and the whole of Selwyn District need to have the courage and foresight to ensure Council funds are invested wisely by future proofing the amentities built for both the local community and the tourists to the district.

Supporting Information

Beyond the land made available by Selwyn District Council for heritage museum-like activities are the facilities owned and presented by one of New Zealand's foremost A&P Associations (Ellesmere Agricultural and Pastoral Association). Imagine the activities that could be generated by locating the proposed new Community Centre amidst the A&P Showgrounds, Ellesmere Heritage Park's Events and Cultural Centre alongside possible future boutique campervan and accommodation area and facilities, all with outreach tourist opportunities and offerings to hand. The long term concept for this area could be to later incorporate a camp site to the east on the site of the show day car park (owned by A & P).

The Ellesmere Heritage Park stands poised as a vital cog in enhancing local infrastructure, which will allow Leeston, Ellesmere District and Selwyn to benefit from the opportunities ahead. The past is important. The geography of the region presents exciting options. The campervan industry has been central to recent developments and changes in tourism which allows tourists to visit parts of NZ that were previously, comparatively, inaccessible.

Significant freedom camping activity takes place at both Chamberlain's and Coe's Fords. Currently, campervans and others resort to freedom camping circa 7 km or more from Leeston. This is an opportunity missed, particularly so when trends in tourist numbers and accommodation styles are considered. Campervan tourism is at the heart of New Zealand's Tourism activity, particularly when tourists venture from the main cities and highways. Hence, time has come for a boutique camping and campervan initiative in Leeston. It's time that local businesses gained benefit from what is happening elsewhere.

Tourism in New Zealand is increasingly defined by Camping/Camper Vans and cycling. Visiting New Zealand is about a slowing the pace of life and experiencing the great outdoors and our agricultural heritage. It has been shown throughout the country, most notably in Otago, that the best way to experience the great outdoors is to cycle, walk and ride. If we ignore these trail opportunities we risk reducing our capacity to grow quality tourist operations.

During the past decade the NZ Government, with others, has developed 22 cycle ways covering more than 2500 km designed to cater for domestic and international tourists looking to get "off the road". In 2015, Ministry of Business, Innovation and Employment estimated that cycle trails made an economic contribution of more than \$49m in benefits to the NZ economy.

New Zealand Business, Innovation and Employment have published a plethora of information on the 22 Great Rides of the New Zealand Cycle Trail, including:

In 2016, an evaluation was conducted for the 2015 calendar year.

An independent cost benefit analysis was used to assess the economic and social benefits of the New Zealand Cycle Trail. MBIE also reviewed the governance and management of the Great Rides and identified some of the key factors of success.

Key findings

For the 2015 calendar year:

- An estimated 1.3 million users visited the 22 Great Rides in 2015.
- Approximately 86.5 per cent of users of the Great Rides were New Zealanders, and just over 114,000 or 13.5 per cent were international visitors.
- For every dollar attributed to construction and maintenance of the Great Rides in 2015, approximately \$3.55 of annual benefits was generated.

- The economic contribution of the cycle trails in 2015 was estimated at \$37.4 million.
- The social contribution of the Great Rides was estimated to be \$12 million. This includes reduced mortality and cost savings from diseases associated with physical inactivity.
- Key factors of successful governance included having a clear strategy, marketing expertise and dedicated resource for trail maintenance."

Even with 22 Great Rides there is ample room for more. Focus on provision of circular trails linking points of interest with a designated area, linking with others, eventually creating a cluster for easily accessed day rides or weeks of enjoyment as domestic and international cyclists look for active recreational holidays and/ or NZ experiences.

The cycle trails are reasonably evenly distributed throughout New Zealand but there are clearly defined areas that are not included. The Little River to Motukarara Trail does not count. It does not comply. What it needs is to be extended around the shores of Lake Ellesmere to Leeston, Southbridge, then off to Hororata, across the Rakaia and on. For cycle trails, also campervans, tourist trails, accommodation, meals, horse trekking, tractor trips, farm displays, reinvigorated communities, community pride, health, wellness, prosperity and wellbeing.

Business opportunities for Leeston could include a cycle hire, transport and repair businesses. Lake Ellesmere beckons. Horse trekking, tractor-trailer tours, Tuna (eel) feeding, boat charters, farm displays, all of which have the potential to become everyday enterprises. The world has become aware that New Zealand has become a considered, global destination.

Imagine the benefits of a cultural and heritage tourist trail stretching from the McKenzie Basin through Mid-Canterbury, across the Rakaia Gorge, down though Hororata, Leeston, along the northeastern boundaries of Lake Ellesmere, to Motukarara, Little River and Akaroa. New Zealand, "off the beaten track", for the world to visit, enjoy and understand.

Ellesmere Heritage Trust is well positioned to learn from the successes and failures of similar 'not for profit' community organisations. Those that have succeeded have put the business of their respective Hubs first and foremost. The interests of member clubs and organisations, and of on-site leaseholders, are important but it is the Hub itself that must succeed and flourish in the first instance. The Heritage Trust can thus take a leading role in supporting and encouraging other on-site organisations by allowing them to flourish. It is not the Trust's role to manage other organisations but there may be ways they can support, encourage and provide services. Provision of infrastructure to deal with the inevitable onslaught of tourism has become a priority. Tourism of the future will be based around events (our cities) and camper vans (off the beaten track). The opportunity to gather our stories, our past and our culture together is "now!" Cycle ways are a huge part of the opportunity. They are not an NZ-exclusive thing/opportunity/phenomenon. The model is well proven in Europe, America, Asia, Australia and elsewhere. Nowhere else though, have others been able, or have the opportunity, to, make their cycle ways a fully nationwide network. New Zealand may not be quite there yet but we are well on the way.

Cycle Trails are just part of the mix, but perhaps more than other means of enjoying New Zealand, they provide great experiences and work best to our advantage.

The opportunities to Selwyn District are endless and the Selwyn District need to have the courage and foresight to invest Council funds wisely by future proofing the amentities built for both the local community and the tourists to the district.

I am fully supportive of an extension to the current aquatic centre facility and believe that the proposal is the minimum upgrade required. I would however, like the council to be more focused on future proposed growth within the region and look at a more sustainable option such as a 50m pool with a movable bulkhead. I appreciate that the SDC is in part guided by the wider Spaces and Places document which was developed post 201/11 earthquakes and the "requirement" for there to be only 1 50 m pool in the wider Canterbury district, however I would also like to draw attention to the lack of progress by our CCC neighbours in this area and the continued delays. As a result, swimmers across Canterbury are missing out on opportunities to train and compete locally in such a facility and an entire generation has missed out on such opportunities due to the obstacles faced as a swimmer. In addition, the growth in the district and the increasing demands being placed on the current facility are not likely to be resolved should the current proposal be adhered to. Already the demands being placed on the facility far out strip the addition of a 25 m pool.

I am fully supportive of the development of a indoor court/sport hub facility to compliment the other developments occurring at the Foster Park location. A facility such as that proposed will provide massive benefit to the wider Selwyn District not only from a sporting perspective but also a viable option to host a number of community and commercial events which are currently untenable. It has long been recognised that hubbing of like minded groups increases productivity and efficiency through the sharing of resources, expertise and knowledge and is a model demonstrated across NZ. The proximity of such a hub to sporting facilities is not only sensible but necessary. Indoor facilities such as those proposed will allow sports within the district to increase participation thereby meeting the needs of the community and supporting the goal of a healthier, more active population in an attempt to reduce the number of incommunicable diseases and illnesses that are currently on the rise. In addition, there are a number of sports and activities (e.g., basketball) in the district that have been undercatered for historically that would provide increased opportunities for our young people to engage in healthy and positive pastimes. As a strong supporter of netball I also see massive benefits to the Sport in the Selwyn District for such a facility - allowing games to be played inside has been proven to increase enjoyment and therefore participation rates. No doubt a change to the current delivery models will be required to allow and enable all potential tenants to access the spaces, however change is inevitable with progress and will in fact mirror the changes in society and possibly allow for greater engagement from people otherwise unable to commit to traditional sport delivery models.! User pays is inevitable - however I don't believe that the Rolleston ratepayers should wear the brunt of rate charges as the development of this facility will be both utilised by residents from all areas within the District, but businesses and individuals will also benefit from its development. In addition an ongoing user pays model will be required to ensure the upkeep and ongoing maintenance of such a facility. There are numerous examples of where this has been done successfully and economically (e.g. the Edgar Centre in Dunedin) which should be explored further. Key to this

however, is ensuring the focus of the development is on function not form - something I am sure will be kept at the forefront of all decisions being made.

I wish to make a submission relating to the proposed extension to the Selwyn Aquatic center.

As on of the pools most regular swimmers and somebody who has considerable experience in competitive swimming over more than 30 years, strongly support the proposal to construct an additional pool in Rolleston.

This is a community necessity with a growing population. The many different user groups makes it difficult for the general public to access lane swimming today.

However, I would recommend some amendments to the proposal. These are as follows:

- 1. Making the additional pool a 50m pool with boom that would allow it to be used as either a single 50m training/competition pool or as two separate 25m pools. There are no other competition grade 50m pools in Christchurch at present with the only other option being the new Metro Sports facility which has been plagued by multiple issues. Other 50m pools across the south island are either outdoors (Jellie Park, Timaru, Nelson) and closed for half the year or as far away as Dunedin and Invercargill. The new QE2 pool "could" add a 50m pool "at a later date" and "if required" which means it is years away. Whilst a 50m pool may be an additional near term cost, it could be offset by taking on board notes 3 and 4 below. In addition, the cost now would be significantly less than doing it in the years to come.
- 2. Ensuring that there is sufficient spectator space to cater for the many competitions that the pool already holds. Some current events require both competitors and spectators be ushered in and out for their respective races as there is woefully inadequate seating.
- 3. Removing the fitness center. Rolleston and the Selwyn district is already exceptionally well catered for in the private sector and does not need additional public funding. A brand new sports center has just opened in the center of Rolleston and the events centers / community halls happily cater for fitness classes the plan is to build a new on of these in Rolleston as well. The money for the fitness center could be better spent on items 1 and 2 with a greater emphasis on promoting and freeing up land for the private sector to invest in the general fitness arena.
- 4. Re-scale or remove the Cafe. \$1.1M on a Cafe and outdoor courtyard is quite frankly outrageous (that's two complete new houses, including land, in a local subdivision). Whilst the details are yet to be determined, I would expect the running of the Cafe to be outsourced like other similar models which means any profit won't even go back to the council for reinvestment into the community. With the playing fields and playground over the road, the benefits of some form of a Cafe may be justified. However, I would suggest leasing a piece of local land for a privately funded construction or if the council really want to invest, to scale it down to something more appropriate. Graham Condon facility does not have a cafe. Pioneer, Jellie Park and Timaru all have small indoor cafe's at no more than 20sqm each (including "kitchen" area). Ashburton has a slightly larger Cafe that also serves hot food (including chips) seeing as this is a sports facility, I would suggest a smaller, health oriented Cafe may be more appropriate.

Cycling & Walking Strategy In general terms I am supportive of the cycle and walkway strategy as proposed within the LTP, however I would encourage the council to consider accelerating the program, and inclusion of budget/projects to the LTP, to provide a more complete network. Detailed feedback as follows:

The benefits realisation for a cycling network are back-loaded, meaning that the usage increase will not be linear with the investments made, and are more likely to be exponential when the cycling network is nearing completion, when the opportunity exists for cyclists to complete the majority of their journey on a 'safe route'. With this in mind, I would encourage the council to consider accelerating the program for completion of the cycle & walking facilities, and consider additional funding/endeavours to 'close-the-gaps' between some of the current projects proposed, to provide a more complete network between our townships. A partially completed (and given the above assertion, under-utilised) network may also make it difficult for the council to gain support to complete this in future LTP rounds.

I do appreciate that the Selwyn cycling strategy/plan is significantly different from others, where this predominantly is an inter-township network (as opposed to an in-town network), so we generally will have greater distances involved, with lower population density. Whilst both these factors can result in a comparatively higher-cost-per-ratepayer, the greater distances can also mean that the benefits are greater too.

Whilst a commute from Rolleston to Christchurch is already achievable for an averagely fit person, the recent upsurge in e-bikes (combined with continued price/performance improvements), will easily place other longer commutes within an average persons reach (e.g. Darfield->iZone, Kirwee->Christchurch).

With respect to completing the network, funding and plans should be included in the LTP (at minimum) for Kirwee to Rolleston, to provide a connection between Darfield/Kirwee and ultimately Christchurch. This could in part leverage the proposed widening work on Hoskyns road (eventually joining onto the proposed West-Melton to Rolleston cycleway), and/or could either utilise the rail corridor/Railway road.

Whilst I appreciate that the LTP is not focussed on tourist cycle strategy, such a path could be leveraged by future road-touring routes such as Arthurs Pass (including the proposed Sheffield/Springfield->Darfield projects) or Methven/Geraldine directions. It would even help ensure that current 'road tourers' (likely to be a different target demographic, albeit some crossover, to those utilising the 'Mountains to Sea' as proposed in I15) with the likely patrons of the would be more likely to pass through Rolleston (and within reach of its shops/services) as part of their route to/from Christchurch.

Seal Widening I would encourage the Hoskyns road widening to be brought forward, as this should have been considered as part of the iZone development. There has been a large increase of trucks using this road since the development of iZone, and it is evident that 2 trucks passing each other both need to place their wheels in the shoulder/gravel. The intersection at SH73/Hoskyns also needs to be upgraded to coincide with the seal widening (obviously coordinated with

NZTA), as there has already been an increase in the large vehicles using this, and will only be exacerbated by the seal-widening programme on this road. Also see my comments above, regarding the cycling & walking strategy. This widening work could be leveraged to provide an interim on-road cycle-route, to form part of a Kirwee-Rolleston link.

Water New Zealand is the principal trade Association representing the interests of the reticulated water industry in New Zealand. The Selwyn District Council is a member of the Association and several of the Council staff participate in Association activities.

We understand the Council is considering options to introduce chlorination treatment for some community water supplies based on a risk assessment.

The Association is supportive of any proposal that introduces the chlorination of public water supplies with a residual disinfection. It has proven to be a cost effective way of reducing the incidence of enteric, waterborne diseases such as campylobacter which have the capacity to induce sickness and death of those who become infected.

If chlorine is introduced into the drinking water system in accordance with good industry practice, there is no evidence that it results in any adverse public health effects. In fact quite the opposite - the chances of the community being accidentally infected by water borne disease is dramatically reduced.

The science and technology associated with chlorine as a water treatment method is well proven around the world and is generally regarded as good practice by the operators of public water supplies.

There is little point in spending 31% of council income on facilities that will remain unused if the roads are only getting 13% and no longer usable due to current leading edge and future vehicles not being able to function safely without sealed roads and safe well maintained road markings.

These 2 figures need to be exchanged and the increased funding generate by the resulting even larger population increase used to develop the facilities in the following decade.

The sealing of Heslerton Road which is eroding quickly due the heavy tanker traffic it now gets and extending the seal on Frasers/Knivets through to Leeston Rakaia Road which also has increased heavy vehicle traffic are noticable by there absence.

Widening of Frasers Road and the addition of a center line would greatly increase safety on this road which is very dangerous in the dark.

Rates increases should remain within inflation, rate payers do not have bottomless pockets.

Perhaps not part of this plan but the rail crossing on Frasers Road is not suitable for heavy goods vehicles, they do not have room to stop and the crossing it too narrow, closing this junction to heavy goods vehicles so they use the Synlait or Dunsandel exits will greatly improve safety on the rail crossing. Alternatively dog leg the rail line as was done at Synlait so this traffic can exit safely.

I support option 3, avoid chlorination of Selwyn drinking supplies and adopt alternative treatment methods (eg UV). UV disinfection is preferred as it does not alter the chemical composition of the water. There are a number of industries and home hobbyists who rely on the supply of unchlorinated water (eg Fish keeping). The addition of chlorination will impose additional costs on ratepayersa s follows 1. ratepayers that value a chlorine-free water supply will be required to invest in costly water filtration systems to remove chlorine from the supply. 2. High quality water filtration systems that remove (as opposed to simply reduce chlorine concentrations), (eg reverse osmosis) are inefficient from a water quantity perspective. On average, for each litre water of pure water produced from a reverse osmosis system, an average of 4 litres of waste water is produced. Thus additional costs are incurred as a result of increased water consumption. Given the water short nature of the Selwyn catchment, the council should not promotic treatment methods that, ultimately, will encourage the use of inefficient water filtration systems.

While I understand the position of the Council and appreciate the additional information provided during the meeting, I do still have these concerns. Mostly over the effects of long-term exposure. I myself would use Chlorine to treat water in a survival situation, backcountry hiking and the like when no other option was available. But this would be in my control and for a short period of time. I can completely understand the need when these 'transgressions' are encountered but I would like to see better communication - as we saw in the meeting there were people affected by the Chlorination who were unaware of the remedial Chlorination until they turned the tap on.

The following concerns could be covered by the FAQ that you suggested. It was obvious that a common theme is what Chlorine and its byproducts may do to our health over a long period of exposure. These fears are exasperated due to easily available information on the Internet - some forms of which are dubious while others are credible looking. There are reports on both sides of the table by people with impressive looking qualifications to a layperson, and that creates confusion and a valid level of concern.

My points/concerns:

- As Chlorine (or the Hypochlorous acid produced) is used to kill bacteria it would be good to understand what happens to our own gut biome when ingested. Also, any effect on our own cells.
- Likewise, what happens to microbes in the soil when Chlorinated water is used to water gardens, again with Chlorine's ability to kill bacteria, over long periods of time.
- The various reports/studies that certain DBPs from Chlorinated water have been linked to cancer and other disease is obviously a big fear for everyone. While there are also reports indicating no/small risk this would be a good discussion to quell fears. What modern research is there on this subject and has there been any long-term studies on the subject?
- While we briefly discussed the effects of Chlorinated water on home equipment, such as tanks, ballcocks, and pumps, I still find it peculiar that a number of people had failures in the same few days, all with the ballcock. Those I have seen show corrosion and pitting around the problem areas. There have been studies with bleach and the corrosion effects on stainless steel. In short, the acid in Chlorine based bleach produces pitting over a short span (bleach based on sodium dichloroisocyanurate does not). It would be good to see some evidence-based reassurance that our home equipment is safe, or if not, steps we can take to protect it.
 - On this subject, I have heard anecdotal evidence that Chlorinated water increases failure of fittings etc. This was based on observations from people that lived in Picton and allege that the community there were frequently replacing parts.
- I have read about concerns that Chlorinated water poses a future risk in that harmful bacteria may become immune to the disinfection process, similar to the problems we are facing with antibiotic-resistant bacteria. The argument is made that alternative measures are made to safeguard the water supply with references to the infrastructure used in cities such as Berlin (I've no idea how it compares to NZ standards or what experts really think about their solutions).
- Humans make mistakes and the worry that accidental overdosing or using the wrong chemical is valid. While I consider this a low risk it would be good to make the controls transparent to alleviate fear and also list any process in place that can detect this.

Another question I have: is the test results taken on the water supply publicly available? I note that LAWA.org.nz documents water quality over time at the source. It would be of interest to see similar for the network and may help people understand the overall health of our water.

Finally, I have a suggestion, whether Chlorination goes ahead or not. People are passionate about their water and a number of people were commenting on getting filters to remove the Chlorine and who was to pay etc. It does sound like the filtration industry is a good place to take out shares at present... How feasible is it for the Council to bulk purchase suitable home filtration units and supply them to ratepayers at cost? This could work on a pre-order basis to establish interest/demand.

I believe this would have numerous benefits including:

- 1. Give people a more affordable method of removing Chlorine from their supply. (and maybe low-income households could pay back over time)
- 2. Further safeguard the home water supply from contaminates should any failures in the network occur. This may also be beneficial from a Civil Defense point of view in times of severe weather or natural disasters.
- 3. Restore some faith back in the Council and show understanding/sympathizing with the different viewpoints, beliefs, and fears within the Selwyn community.

I am submitting on behalf of the Guild family at High Peak Station. One of the most fundamental functions of council is transport infrastructure. In our case, this means roads. Specifically, we would like to see increased priority on the maintenance and safety of the High Peak Rd, Snowdon Rd, Zig Zag Rd and Leaches Rd.

The first three are gravel roads that over the course of a calendar year can range from excellent condition to incredibly poor condition. It is the long periods of deterioration between maintenance intervals that make these roads unsafe, as exemplified by the current state of the eastern end of the Snowdon Rd.

Leaches Rd is simply too narrow for the volume and size of traffic that regularly use it (e.g. milk tankers, logging trucks, CPW equipment). The edges are constantly eroded and potholed and everyone in the district seems to have a story regarding damage, an incident or a near miss. It needs to be rectified as a matter of urgency.

In context, many of the projects outlined in the Long Term Plan that you have invited comment on seem to be frivolous when faced with marginal roading infrastructure and in our view, way down the priority order.
