Master Plan projects for the site. Significant progress has been made with field improvements, the West Melton Community and Recreation Centre and the West Melton Community Park.

The West Melton Reserve Board (WMRB) has been working closely with Selwyn District Council (SDC) to complete the

Recent consultation from Waka Kotahi / NZTA on a proposed SH73 / Weedons Ross Road Intersection upgrade that

includes a realignment of West Melton Road, has highlighted traffic flow and parking issues for the Reserve. Parking is already an issue at both the West Melton Road and Community Centre entry points, and the proposed roading changes would create additional challenges for motorists, clubs and reserve visitors.

WMRB are supportive of the Waka Kotahi / NZTA intersection upgrades as it improves community access to the reserve. However, we would need to address access and parking at several locations, such as:

- 1. South carpark (known as Bowls carparking). The sealing of the area is currently budgeted for 2027/28.
- 2. North of Rugby / Scout Den. Currently existing tennis courts which are not scheduled until 2026/27.
- 3. Additional parking at the Community Centre as marked. We believe this entrance point will be come much busier with the growing use of the Community Centre, wider use of the Community Park and preference to walk / run into the Reserve via the SH73 to avoid the West Melton Road entrance.
- 4. Additional spaces created by the West Melton Road cul de sac formed from the intersection upgrades. We understand this is outside the remit of the WMRB and sits with SDC roading improvements. WMRB welcome community consultation on this as the proposed SH73 / Weedons Ross Road Intersection upgrade progresses.

WMRB recommends to SDC the construction of new Tennis / Netball Courts be brought forward to accommodate item 2 above and to align with other construction activity. The new courts are to be located adjacent to the Community Centre. Currently this is scheduled for 2026/27.

A community running track project is also shown on the master plan that should be completed as part of these improvements. The first stage of this was commissioned in late 2020.

WMRB welcomes the opportunity to progress these projects much earlier than currently forecasted to coordinate construction activity and resources with Waka Kotahi / NZTA and to meet community expectations.



### West Melton Reserve 10-year Financial Programme

#### Feedback from the West Melton Reserve Board Committee

### Background

The Reserve Board have been working with SDC officers over the last 10 years to develop and implement a Master Plan for the reserve. The Master Plan has been developed to:

- 1. Integrate new land areas and the new Community and Recreation Centre into the reserve
- 2. Plan for additional sporting fields, recreation and landscape areas
- 3. Plan for parking, vehicle and pedestrian movements across the reserve.

The Reserve Board endorses the Master Plan prepared by Council (led by Derek Hayes) and is keen to see it delivered in a structured and efficient way over the next 5 years so that the Reserve can continue to provide the facilities sought by the growing West Melton Community.

### 10-Year Financial Programme Review

The Reserve Board reviewed the draft financial programme at our monthly meeting on 21 September 2020. We were supported by this meeting by Derek Hayes and Councillor Jeff Bland. We provide below feedback on the proposed programme. This document should be reviewed in conjunction with the Master Plan and the draft 10-year Financial Programme.

### **Priority Capital Projects**

#### Youth Area Adjacent to the Community Centre

- 1. Highest priority project.
- 2. The youth area has strong support from the Reserve Board and community. It is ideally located next to the community centre where it is away from houses but close to parking and areas where people visit and walk.
- 3. The draft financial programme shows funding for the development of the youth area in the 2020/21 FY and 2021/22 FY. This consists of:
  - a. Renew playground equipment \$62k (this is for the new playground. The existing playground next to the tennis courts was repaired and brought up to safety standards by the Reserve Board and SDC in around 2018)
  - b. Playground undersurface \$17k (associated with the playground)
  - c. Domain extension development \$274k + \$80k
  - d. Skate/scooter/bike park \$250k (it is not clear on the draft programme where this sits)
  - e. Perimeter Footpath \$41k + \$30k (note that around \$60k of this has been spent on Stage 1 of the perimeter path).
- 4. The Reserve Board supports this timeframe and funding for the development of the youth area.

- 5. The skate/scooter/bike park is being designed by Dave North of Nelson Creek Skateparks and Boards on behalf of SDC. The Reserve Board recognize the importance of a well-designed skate park and support the location shown in the Master Plan.
- 6. The Reserve Board are keen to see that the skate park is well integrated into its surroundings so that it encourages positive social interactions, provides a safe place for all ages and brings people to the area. On behalf of the reserve Board, Allan Spinks will be providing feedback on how the following items can be integrated with the skate park design:
  - a. Perimeter path and fitness equipment
  - b. Elevated picnic/viewing area
  - c. Childrens playground
  - d. Half-Court Basketball
  - e. Common community area. The Reserve Board are keen to see if a common community area can be incorporated into the layout to allow community events (eg Anzac Day commemorations) to be staged in this area.
- 7. The Reserve Board would like to see the perimeter path constructed around the youth area and linking back to the football carpark as part of this development. This will provide a pedestrian and cycle link between the new community centre and other buildings and carparks in the reserve.
- 8. Lighting will be required to the youth area and to the path linking the youth area to the football carpark.

#### Tennis and Netball Court Relocation

- 1. Second highest priority project.
- 2. This project involves constructing 8 new tennis sized courts to the south of the community centre and repurposing current courts for carparking and sports fields.
- 3. The current tennis courts are used from September to April by the WM Tennis Club and from April to September by the WM Netball Club for training and games.
- 4. The WM Tennis Club (with the support of WM Netball) have separately provided information to SDC on the condition of the courts and justification for their relocation. This information, which included a court condition assessment, concluded the following:
  - a. The number of courts is insufficient for the needs of the clubs. Tennis currently need to make use of other courts in WM village, and play home games away from WM due to the demands on the courts. It is proposed that 8 new courts be constructed to replace the existing 6 courts. Refer to the appended email to SDC.
  - b. 4 of the 6 courts are sub-standard for club tennis due to poor surface condition and drainage.
  - c. The different elevations of the courts present a safety hazard to players due to the uneven ground and grass that separates the courts.
  - d. Lighting at the courts is insufficient for evening training and games.
  - e. The current location of the courts close to the main vehicle parking and drop-off area presents a safety risk to young tennis players and netballers.
- 5. The relocation of the courts will open-up valuable space close to existing community, rugby, scouts and bowls facilities for carparking. On busy rugby days, all carparks are full and parking occurs along both sides of West Melton Rd, which presents a hazard to pedestrians and vehicles.

- 6. The draft financial programme shows funding for the relocation of the courts in the 2023/24 FY and 2024/25 FY. This consists of:
  - a. Tennis Court Replacement \$360k
  - b. Domain extension development \$140k + \$130k
- 7. The Reserve Board proposes that the court construction commence a year earlier in the 2022/23 FY. The court relocation will allow the completion of much needed additional carparking and the perimeter path.
- 8. The new court area will need a volley wall and lighting.

#### Perimeter Path

- 1. The perimeter path project is the construction of a perimeter path around the outside of the reserve. The path will provide a cycle and pedestrian link between the different carparks and facilities across the reserve. It will also provide an exercise track around the reserve (1.2km long) as an unformed trail around the perimeter is regularly used as a running track.
- 2. Stage 1 of the perimeter path has just been completed. This is a grit (hoggin style) path that has linked the bowls carpark to the end of the existing path at the football carpark (crossing in front of the rugby club).
- 3. In conjunction with Stage 1, the WM Bowls club replaced fences along the west and north sides of the bowls facility.
- 4. Security lighting is required along this path and additional bollards need to be added to the section through the bowls carpark to stop vehicles parking on the path.
- 5. Further stages of the perimeter path construction can be added as the youth area and tennis court relocation are completed. In the interim, signage will be erected to show the path route and run distances.

### Club Developments

The following club developments are planned:

- 1. Weedons Cricket club are seeking additional grounds to hold junior cricket matches. The club has experienced significant growth in numbers and currently has 7 junior teams (around 60 players) of West Melton based children. The area to the north of Rugby Field 3 will be used this year for cricket matches. The club is working with the Reserve Board to identify possible locations for permanent pitches and nets on the reserve. The Reserve Board supports the addition of cricket to the reserve and supports the allocation of funding to support this.
- 2. Selwyn Football currently runs junior football matches on the reserve. Around 60 West Melton based children are involved in the club and playing numbers continue to grow. The club is looking to convert the current junior fields into a single senior football field. This will result in the need for additional junior fields on the reserve. The area to the north of Rugby Field 3 has been identified for this. The relocation of the tennis courts will free up further land for playing fields, that can be shared between junior rugby and junior football.

### Other Projects and Expenses

The following minor projects are important for the continued upkeep and operation of the reserve:

- 1. Carpark repairs to the main carpark. This was delayed by Covid 19 restrictions but should proceed this summer (\$20k).
- Irrigation improvements. Pump shed improvements (new pump VSD, irrigation controller and expanded pump shed) were completed in March 2020. Sprinkler head placement is currently underway. A replacement well pump has been budgeted for but will only be used when required.
- 3. Bowls club fence replacement. The Reserve Board supports the allocation of funds to support the Bowls club in replacing fences around their facility. We note that draft plan includes a \$12k budget again fence replacement.
- 4. Drinking fountains. New drinking fountains will be installed to replace current fountains that require significant maintenance. One fountain will be relocated from its current location next to the toilet block to be closer to the path, tennis and playground.

The following maintenance activities need to be budgeted for:

- 1. Field mowing Bruce Russell
- 2. General caretaking SDC/IZone caretaking staff
- 3. Rubbish management and toilet upkeep Sicon
- 4. Irrigation system operation and maintenance Freeman Irrigation
- 5. Tree trimming, spraying, carpark repairs, electrical and mechanical maintenance various SDC contractors.

We are one of the properties that will have to pay the max connection costs associated with this proposal. Our home is over 60m from the road berm, and means pre connection our annual rates will increase by 54%! Post connection, and taking into account the estimated \$20,000.00, this will increase by over 74%!! I ve always been very proud of our district, including becoming a home owner within Darfield. The later especially so given we re the first NZ home owner swithin my whanau, ever!!! Unfortunately, this proposal, and in particular forcing the bulk costs associated onto a limited number of home owners (including ourselves) is quite simply implausible! I know there le within Darfield who are not in a financial position to afford this, and quite simply, neither can we!!

Although I support a sewer network overall, there is no environmental or public health concern supporting this rushed proposal. And fail to understand why this was the only option presented. I know there has been much consultation, analysis and discussion around this (particularly since these costs were incorporated into my annual rates).

I don to see any considerations to help reduce these costs forced onto a limited number of properties. Considerations such as mass building consents, or bulk low pressure sewer system purchases. Maybe even a short list of preferred and reasonably priced contractors. Ideally, considerations such as spreading costs across Darfield/West Melton areas, or even district wide (I know I pay costs through my rates that I, nor my whanau reap benefit from).

In summary, we just can this proposal. And have no other option but to support Option 2. Particularly for existing properties. I do support, that this installation/connection begin with new property development within the region/s. Why fix something which quite simply, isn't broken!

**Staff Comments** The submitters preference for Council to upgrade some supplies so that they can

avoid chlorination is acknowledged. This option means additional funding and upgrades, with the specific purpose of avoiding chlorination, would need to be added within the 2021-31 LTP as additional projects. The additional cost of this option is estimated to be \$30M capex and an additional \$0.2M operational expense. The increase in the water rate would be around \$100 per year per property. It is proposed that an exemption from chlorination from Taumata Arowai would be required prior to spending additional money on our water

supplies.

#### Submission regarding Foster Park - Full size artificial hockey turf

I am currently involved with Waikirikiri Hockey Club as a player, coach and Senior Club Captain, and I am 100% for a water turf for Hockey being established at Foster Park.

In order for the Waikirikiri Hockey Club to continue to grow in the community and further its vision and purpose to create healthy families in the community through an established and credible sports club that performs at every level, and to grow the game of hockey with the ethos People, Pathways, Performance, it is essential that a full sized hockey facility is established.

A full size water turf offers advantages over the current sand based turf in that a watered pitch presents fast, consistent playing conditions, and a soft surface means that it doesn't impact on player's knees and joints as much from the repeated impact of many hours of play. A water turf is far superior to play on and will result in less injuries as it's nowhere near as harsh on the body.

Currently the club has outgrown the current turf as numbers continue to increase year on year. Practice times are at a premium with teams often having to share the turf to ensure every team can practice weekly. This is only going to get worse as the club grows going forward. With us having more teams in the senior competitions than ever we need a fill sized turf in order to have proper practices as the current turf is too small and there are no time slots available. This will become more important when we gain entry into the top grades of CHA hockey over the next few years. Currently our top men's and women's teams have to travel to Christchurch each week in order to have a late night practice starting at 8.30pm which is far from ideal.

A full size Turf would enable the expansion of the clubs social competition. Most recently there were 10 adult teams involved with players from teenage years all the way to over 50's taking part. The teams included a number of adults new to hockey in the past year who instead of watching are now actively participating in the sport which will have benefits to their overall health. A full size turf would enable us to add more teams going forward and therefore get more people of the couch, as well allowing us to explore different competition options from 5 aside to 11 aside hockey.

I have in my time with the Waikirikiri Hockey Club found that a community has formed around the club. I and many others have made many friendships with people we would never have met otherwise. It enables myself and many other people to get away from the daily stresses of normal life, to exercise and have fun in a safe welcoming, family friendly environment. A full size turf would enable more of people to have access to this environment which can only be of benefit to the whole community.

#### Community Facilities – Full Size Artificial Hockey Turf 2021

In 2016 Waikirikiri Hockey was formed to provide the opportunity for people to play hockey locally. The Selwyn District Council, with funding support from NZCT and CAST, Provided the Small Turf at Foster Park as the local facility for the club to train and play.

The Vision of Waikirikiri Hockey is to create healthy families in the Selwyn community through an established & credible sport club.

- In 2021 the club is well established. 25 teams participating in the Canterbury Hockey Competition, and 8 teams playing in the club winter social/business house competition. These teams cater for all ages from School year 1 to Adults.
- Waikirikiri Hockey credibility has been proven with its operational systems supporting the nomination and resulting awarded as Hockey New Zealand, Club of the Year 2019.

The Purpose of Waikirikiri Hockey is to grow the game of hockey with the ethos: People, Pathways, Performance.

- Waikirikiri Hockey has developed a community of hockey players, administrators, coaches, umpires, sponsors and supporters. The people engaged in the club are local Selwyn people. The players range from 5 – 58 years old.
- The Canterbury Hockey Association (CHA) Competition is the main player participation
  pathway. The CHA Constitution allows clubs to be formed from the ground up and therefore
  Waikirikiri Hockey is required to grow through the grades and maintain a solid junior
  platform. In 2021 the club has the top team participating in Men's and Women's Division 2,
  with plans to grow into both Division 1 and the Premier Grade by 2026.
- Waikirikiri Hockey Run a local Social Hockey Competition at Foster Park in the winter for adults and summer for juniors and adults.

In 2019 Waikirikiri Hockey started discussions with the council on the provision of a full sized turf to meet the growing demand. A Needs Analysis Business Case for a full size hockey turf was presented.

- The basis for this business case is that the modern game is played only on artificial surface
  and a full turf facility is required to enable the club to continue to grow to have teams
  participating at all levels from primary children to Premier Adults and that all of these
  players can train locally.
- The current small turf is operating at training level capacity with trainings book from 3:30pm - 8:30pm and is limiting the growth of the club and the ability to meet the needs of the people wanting to participate in Hockey, this includes training time for local High Schools.

- This business case is supported independently by the New Zealand Hockey Facilities
   Strategy 2016 Indicate Latent Demand Indicator, when there are over 40,000 residents per
   full turf the lack of facilities will be a barrier to participation. The SDC population forecast
   in 2020 at the time of submitting the business case indicated the WKK catchment area of
   the Selwyn District to be above 40,000 in 2026, the current model indicates there to be
   43,242 in 2021/22.
- The facility will generate income from Canterbury Hockey for schedule competition games.
  The small turf at Foster Park will continue to generate an income from CHA as it has since
  2016 for Saturday Junior Games. The Full Turf will enable generate income from High
  School Competition Games on Wednesday and Friday's, Mid-Week Competition Games on
  Monday and Tuesday's, Senior Competition Games on Saturday and Sundays. In the
  Summer there will also be income from Masters Games.
- This needs analysis detailed the need for the provision for a full sized hockey turf to be included in the 2021-2022 Long Term Plan. With the facility to be built in 2021 for use in the 2022 season.
- A Full Turf Use plan shows that both the full turf and half turf can both be expected to be used at capacity in 2026. At that time The club will have grown to have teams in all grades, local high schools will train and play, The local Social Hockey competition will be able to cater for more teams and CHA will use the turf 6 days per week with competition games. There will also be usage for club player development programs and pre-season and end of season tournaments.

As the small turf at Foster Park is now operating at full capacity, further growth of both junior teams and into the senior grades is very constrained, 11 aside teams would be required to travel into the city to train. In 2021 we have two senior teams travelling to Nga Puna Wai for weekly training at an 8:30pm training slot.

The Club has a full and enthusiastic committee and community who are excited about enabling the club to continue to grow and provide the opportunity for more people to play and engage with hockey with the provision of a full-sized hockey turf.

We would like to thank the council staff (including the late John Reid) and councilors' for responding to the needs of the community with the provision of facilities to meet the demand in the community for people to play hockey.

- The Canterbury Artificial Surfaces Trust ('CAST') was established in December 2000 with the
  endorsement of Canterbury Hockey Association (Inc) ('CHA'). The principal objectives of CAST
  are to finance, undertake maintenance of a capital nature, and to develop artificial hockey turf
  surfaces and facilities for the benefit of hockey in Canterbury.
- 2. CAST works very closely with CHA in planning the development of artificial turf fields, to meet the demands of hockey's growth. CAST has many years' experience in the development of turfs, including technical aspects, funding, management and maintenance.
- 3. Over recent years CAST has, in association with CHA and Waikirikiri Hockey supported the development of artificial hockey surfaces in the District. CAST has been delighted to see the progress of hockey in the Selwyn District. It notes that:
  - Waikirikiri Hockey has made huge progress since its establishment and has grown from zero to 25 teams in just 5 years, a phenomenal performance. As such it fulfilled all the initial targets agreed with CAST, that had advanced seed funding to the club and accordingly the advance was converted from a loan to a grant to Waikirikiri Hockey.
  - The half-turf that was installed at Foster Park in 2016 was a fundamental component of the game's establishment and was highly successful in 'proving the concept' that there was a local demand for an artificial surface, not just for hockey but as a community asset.
  - In CAST's experience it is essential with any turf development that there is a strong entity that is responsible for its activation, and that there is a committed leadership group to plan and implement growth. Waikirikiri Hockey has excelled in this, as evidenced by the Club being awarded New Zealand Hockey Club of the year 2019.
  - CAST is very pleased to note that planning for a full-sized turf to be installed at Foster Park later this year is well underway.
- 4. Fundamental to the establishment of turf facilities is that they provide for 'local communities to play hockey locally'. With increasing pressure coming on reducing carbon emissions coupled with projected growth of Selwyn District, and at the same time the projected growth of hockey in the District, CAST strongly supports Waikirikiri Hockey's proposal that the Long Term Plan should include provision for (an) additional artificial hockey surfaces in the Selwyn District.
- 5. Also fundamental to establishing new facilities is that there is a strong professional local club that can activate the facility and maximise the utilisation. In CAST's opinion the Waikirikiri Club has already proved it has that capability.

  - Providing and/or sourcing technical planning assistance
  - Assisting in the evaluating possible locations for suitability
  - Advising on design considerations
  - Facilitating introductions to experts where necessary
  - Advising and/or assisting with financial planning and funding options
  - Advising on management and operational aspects of turfs
- 7. CAST believes that developing artificial hockey surfaces can deliver significant benefits for the community:
  - The all-weather nature of the facility means that players enjoyer fewer weather-related cancellations.

- The artificial surfaces, if well-maintained, can cope with a high level of usage, throughout the whole year.
- It enables players of all ages and abilities to play hockey safely on a sympathetic surface.
- By building hockey facilities within the region players and parents are able to reduce the need to travel to Christchurch for games and practices.
- 8. CAST congratulates the Council on its work on developing sport and recreation facilities as widespread sports participation delivers demonstrable community benefits.
- 9. CAST will be happy to assist the Council where possible to develop this opportunity.

As the entity response for the long term governance and management of the delivery of hockey in our region, we are pleased to submit on the recent Selwyn District Council Long Term Plan.

- 1. Canterbury Hockey Association Inc. was established in 1989 with the purpose of developing and implementing strategic plans that will Hockey are to develop and implement strategic plans that
  - grow the participation levels of all participants in the game of hockey;
  - offer the widest possible opportunities within the Boundaries for all persons to participate in the game of hockey and
  - to make hockey a readily accessible sport and recreation for all.
- 2. Canterbury Hockey Association boundaries includes the territorial boundaries of Christchurch City, Hurunui Districts, Waimakariri District and Selwyn District (excluding the Malvern ward; the area in the Selwyn Central ward north of Main South Road and west of the continuation of Dawsons Road and Chattertons Road from Main South Road in the south to the Waimakariri River in the north; and the area in the Ellesmere ward north of Main South Road). This area is currently still governed by the Malvern Hockey Association however Malvern enter teams into the Canterbury Hockey competitions.
- 3. The general growth in the sport of hockey continues to trend upwards, which is in contrast to many other sporting codes. Increases between 2016 to 2019 averaged 8.7% each year and this provides an estimated player base in Canterbury of around 6,315 players.
- 4. As hockey moves more and more towards a year-round sport and the opportunities to play become more diversified (modified games for young people over the summer months, significant growth in Masters Hockey and more social and informal formats), participation numbers become harder to define. Probably of more challenge however is the ongoing impact this growth has on existing facilities as popularity of grass facilities continues to decline (we have 4 grass teams registered only for the 2021 season).
- 5. Canterbury Hockey has supported the establishment of hockey in the Selwyn region through the establishment of the Waikirikiri Club and becoming an affiliated member of Canterbury Hockey. Since the Clubs inception, the growth in popularity of the sport in Selwyn has continued to grow with 23 teams competing across a range of our junior and senior grades.
- 6. The half-turf that was installed at Foster Park in 2016 was a fundamental component of the game's establishment and was highly successful in 'proving the concept' that there was a local demand for an artificial surface, not just for hockey but as a community asset. In our experience it is essential with any turf development that there is a strong entity that is responsible for its activation, and that there is a committed leadership group to plan and implement growth. Waikirikiri Hockey has excelled in this, as evidenced by the Club being awarded New Zealand Hockey Club of the year 2019.



- 7. Canterbury Hockey is very pleased to note that planning for a full-sized turf to be installed at Foster Park later this year is well underway.
- 8. Fundamental to the establishment of turf facilities is that they provide for 'local communities to play hockey locally'. With increasing pressure coming on reducing carbon emissions coupled with projected growth of Selwyn District, and at the same time the projected growth of hockey in the District, Canterbury Hockey strongly supports Waikirikiri Hockey's proposal that the Long Term Plan should include provision for an additional artificial hockey surfaces in the Selwyn District.
- 9. Also fundamental to establishing new facilities is that there is a strong professional local club that can activate the facility and maximise the utilisation. In Canterbury Hockey's opinion the Waikirikiri Sport (T/A Waikirikiri Hockey Club has already proved it has that capability.
- 10. Canterbury Hockey is willing to assist where possible help bring development plans to fruition. This assistance can be by:
  - Providing and/or sourcing technical planning assistance
  - Advising on design considerations
  - Facilitating introductions to experts where necessary
  - Advising and/or assisting with financial planning and funding options
  - Advising on management and operational aspects of turfs
- 11. Canterbury Hockey believes that developing artificial hockey surfaces can deliver significant benefits for the community:
  - a. The all-weather nature of the facility means that players enjoy fewer weather-related cancellations.
  - b. The artificial surfaces, if well-maintained, can cope with a high level of usage, throughout the whole year.
  - c. It enables players of all ages and abilities to play hockey safely on a sympathetic surface.
  - d. By building hockey facilities within the region players and parents are able to reduce the need to travel to Christchurch for games and practices.
- 12. Canterbury Hockey has been undertaking a Facilities Strategy which RSL has been contracted to develop and this has been supported by both Selwyn District and Christchurch City Council's and the Canterbury Artificial Surfaces Trust. This Strategy, while still in final draft and awaiting sign off by the Steering Group, indicates that overall, we based on playing numbers, the region has not currently have provision of enough turfs based on playing population.
- 13. That National Hockey Facilities Strategy (2016) provides a consistent and comparable indicator to measure turf access measured in Full Time Equivalent (FTE). An FTE turf is defined as a full-size turf that provides at least 54 hours of access per week. There are currently 8 FTE turfs in Canterbury.
- 14. A full turf network is considered to be operating at capacity when the ratio of players who use a full-size turf to the number of FTE reaches 500. In 2020, Canterbury currently has a ratio of 541 players per FTE turf indicating that additional turfs are required to meet demand.



- 15. We are aware of Mainland Football and Selwyn Football Clubs' desire to have further artificial surfaces developed to support their sport. As an organisation, Canterbury Hockey currently works in strategic partnership with other codes and is aware of these desires and motivations. As a sport, we welcome to showcase the benefits and opportunities that artificial surfaces bring to our sport and others and support the multi-use of any these facilities by other codes where it does not impeach on the availability of the turf for hockey activities and when it is safe to do so that is, any non-hockey activities do not impact on the quality or integrity of the artificial surface.
- 16. Canterbury Hockey congratulates the Council on its work on developing sport and recreation facilities as widespread sports participation delivers demonstrable community benefits and is happy to continue to support the Council where possible to further develop this opportunity.

The Department of Conservation supports the Council's proposed changes to the District's Land Drainage Network outlined in the proposed Long Term Plan.

#### Context:

Although largely artificial, the Land Drainage network now represents the remnants of the former extensive Te Waihora wetland. Perrennial, spring-fed drains have become by default the District's lowland waterways. While the drainage network serves to make the former swampland suitable for farming and habitation, the waterways are valuable habitat for many of New Zealand's lowland indigenous species. Water and the species that live there are also taonga to tangata whenua. Ecological and cultural values therefore need to be incorporated into the management of the drainage network.

#### Key points:

- 1. DOC supports the Council's view that there's a growing focus on the environmental performance of the land drainage network to ensure that the network can deliver multiple outcomes. DOC sees many opportunities for considerable improvement to the current management and authorisations for land drainage works.
- 2. DOC supports the establishment of new drainage network governance to ensure better representation of multiple values and enable the delivery of multiple outcomes.
- 3. DOC supports the transition to a District-wide land drainage committee to ensure the District-wide delivery of multiple outcomes, the delivery of consistent best practice and better oversight and accountability on behalf of the Council and ratepayers.
- 4. DOC supports the development of a new rating structure to enable the Council to fund community expectations for

improvements to environmental performance. While many rate payers will continue to benefit directly from land drainage, other rate payers will receive indirect benefits from the knowledge that the Council is delivering improvements to freshwater ecosystem health.

Cancer Society would encourage council to extend it's current smokefree policy to include vaping on council owned land and facilities for current and new developments outlined in the Long Term Plan. This would help contribute towards the SDC outcome to achieve a clean environment with 'Air, land, water and general environment to be kept in a

healthy condition' as it would help lessen cigarette and vaping waste and reduce toxins leeching into water and ground. As the second fastest growing region in NZ with a young family based population this would further support councils commitment to community wellbeing and profile good health behaviour role modelling, especially to young people. This would be entirely consistent with councils support for the government Smokefree Aotearoa 2025 goal, endorsed by Selwyn District Council. More smokefree spaces also support people to remain smokefree during their quit journey, reducing visual cues to smoke. This would also align with the Community services and facilities goal to 'Grow our community shealth, fitness and wellbeing' and 'Grow the quality of the living environment for our residents'. With the array of new building facilities both community services focussed and retail focussed in the region there are some timely opportunities to extend the scope of the current smokefree policy to create more smokefree and vape free public spaces in the region. For example the public square and

high amenity reserve could be designated smokefree and vapefree to help create a 'vibrant and attractive Town Centre for Rolleston'.

Cancer Society would also encourage Selwyn District Council to give robust consideration of shade availability to all major projects where Selwyn residents will be encouraged and welcomed to

'participate in community life'. For developments related to enhancing Parks, reserves and other green spaces such as Birches Road Park in Prebbleton with progressive development happening over a 10 year period and the Rolleston

Reserve Development to create a 'high amenity park', Lincoln Sports Park Extension and the District Park Development for the eastern edge of Rolleston would all benefit from ample shade consideration in the development stages. As areas where residents may be spending considerable time outdoors, a significant proportion of which would be in the peak UV times (times when the UV index level is 3 and above namely Sept-April 10am-4pm) council would be well placed to give due consideration to shade in designing new and upgrading existing outdoor spaces, particularly parks, playgrounds and picnic seating areas. Skin cancer is the most common cancer in New Zealand but is highly preventable. Almost 90% of melanoma and 95% of non melanoma skin cancers are caused by excessive exposure to ultraviolet radiation. Council in including ample shade in new developments and upgrades can contribute to reducing the skin cancer burden for New Zealand. In 2017 a nationwide survey was conducted of playground shade across New Zealand. Of the 559 playgrounds sampled only 44% had at least one source of shade covering playground activity areas (equipment ,seats or tables). Only 14% of playground activity had at least some shade cover. A key finding from the Survey conducted by University of Otago, Wellington and funded by Cancer Society of New Zealand, Wellington Division was that few councils have sun protection policies and that incorporating shade in long term and district plans can help ensure that shade is considered and provided to benefit residents and visitors alike. Township Reserves and Streetscapes Maintenance and Renewal Programmes outlined in the L.T.P and the development of New Neighbourhood Reserves in the region further extend the scope for shade consideration and provision. New centres like the Hororata Community Centre could consider the use of shade awnings or shade provision (whether natural or built shade) for outdoor seating and spaces where people may congregate. Consideration of shade should be an integral aspect of all outdoor sport and recreation facility development. Whilst personal sun protection is important, environmental changes through

the provision of shade offers a more effective way to protect against over-exposure to UVR. A one-off cost at construction can ensure that shade is provided through either natural means (i.e. shade trees) and/or well-designed built structures. Thereby providing practical strategies

to minimise UV harm and enhance enjoyment for the community. The Cancer Society therefore requests that shade be considered as positive and safe enhancement to the many new developments and enhancement projects outlined for the Selwyn District over the next 10 years.

**Staff Comments** 

Shade Cover for playgrounds: An assessment undertaken of play environments a few years ago noted that many sites had adequate shade provided but at around 28% of sites it was deficient. Shade sails and similar structures have been installed at a number of new playgrounds and this is now taken into consideration in the design process (e.g. Foster park, Acland Park, West Melton Community Park). However specific shade structures have not been provided at all new developments with a reliance on shade from trees as they establish. There has been some previous resistance to installation of shade sails due to vandalism and durability issues but this has improved with new products now available. Staff are looking to include the requirement for shade provision (structures and planting) in reviewing the Engineering Code of Practice to ensure this is considered at the design stage. The placement of shade trees in playgrounds especially around seating areas is also undertaken. Generally the cost of shade covers/structures are built in to the development costs for new playgrounds. However for retrofitting on to existing playgrounds additional funding would be required. It is estimated (based on previous installations) \$18,000 per site is required for supply and installation. If Council was to provide additional budget for this initiative it would need to be funded from the general rate or targeted rate for recreation reserves.
