



Regarding the intersection between State Hwy 1 and Browns Rd, Dunsandel.

This intersection is incredibly dangerous and because of the proposed changes on SH1 with some right turns being closed this intersection is going have traffic funneled into it from the likes of Frasers Rd. This sort of traffic will include tractors, trucks and other farm equipment. They would normally cross SH1 at little used side roads but will now have to use Browns Rd as a crossing point.

I am a secondary school bus driver and have experienced two close calls in recent months. The second I documented to my employer as it was a very close call and could have resulted in my bus being clipped and spun sideways. Luckily it was a near miss. There is too much happening at this intersection and a lot of cars will nip across with little thought to us slow movers. Add to that tractors and more trucks and it is a catastrophe waiting to happen.

Add to that the fact there are no barrier arms on the nearby rail crossing could potentially add to a disaster. Imagine someone just having had a close call and are driving with that deer in the headlights tunnel vision and drive straight into the path of a train.

I realise this is an NZTA situation but I implore you as Council to lobby those appropriate to look at this situation especially the funneling of more traffic into this area.

The first thing I would suggest is that no parking be allowed on the eastern approach as this creates

a very big blind spot. see area between (2) and (3) on appendix 2

It's not a matter of if but when.

Also the only dedicated pedestrian crossing if you can call it that is at (1) on appendix 2 pic. That means if children want to use domain or playground this is the only somewhat safe area to do so.

It has been suggested that a dedicated left turn lane from Browns Rd (5) going south will help but will in fact make the problem worse. There is no issue turning left here but a dedicated left turn will make issues further down where multiple trucks stop for food at the Stop Shop see (4). They would have to cross over the dedicated left turn.

The first thing I recommend is remove parking between (2) and (3)

Second thing would be to reduce the speed to 50km

And the third thing would be to install traffic lights. This would provide pedestrians better access and enable much safer vehicle crossings.



Bowls is a fast growing sport that can be enjoyed by anyone of any age. The opportunities for playing bowls in Selwyn are limited especially in Rolleston.

A bowling green was mooted for Foster Park originally but got dropped for some reason.

Bowls is a very non-discriminatory sport that can be played by school children, through to the elderly and handicapped.

Dunsandel here for example has a very stable membership and has approximately 150 paid up members. These members are made up with the core serious bowlers, Community Bowlers and Social farmer bowlers. We also run invitational tournaments where a further 100 players are involved. Add to that the bowlers who come from other clubs on a home and away basis and the total is quite extensive for such a small community. It is pretty much the same across other Ellesmere and Malvern Bowling clubs.

Rolleston needs to develop their own bowling club. The new park setting on Maddisons Rd would be a possible location for this.

I know financial constraints at the moment are not conducive to spending large amounts of money on a project like this but could you at least consider a proper needs analysis and or feasibility study. The council should look to stimulate economic growth by making it attractive to new businesses to move into the area, particularly to Rolleston (Izone). There are few industrial units available to lease or buy in the area.

The growth in under-represented sports continues to perform strongly. It is disappointing to read this long-term plan with no mention of gymnastics facilities. The last long-term plan concluded in a decision to support the growth in gymnastics and investigate building a purpose-built facility for Rolleston to cater for the sport, yet it appears to be conveniently forgotten.

The charity, Affinity Gymnastics Academy Incorporated, is the Selwyn Districts largest charity sports

club with a very large membership base. Three years ago numerous submissions were made to council requesting their support. The council committed to undertake a feasibility report for a new building for Affinity that would be subject to a lease. This was never done and the council ignored repeated requests.

The club currently pays \$160,000 per year in rent to a private landlord for an unsuitable building.

Despite this, the council obviously finds it acceptable to build more floodlit sports pitches for smaller clubs at in Prebbleton for \$11M and an artificial hockey and football pitch in Rolleston for \$4.3M, all to be used by much smaller clubs.

Once again, it is clear that the Council is going well past what is essential into areas that are almost ideological. I am part-Māori but strongly disagree that we need consultation with Māori over everything. I think as a Council you need to do this referendum that this new government has brought in, to obtain a mandate from your ratepayers as to whether they think that sort of consultation and representation, which is not democratic, should be happening or not. I also do not think we need to spend money on climate change issues. We need to stick to the basics of why you exist, especially in a recession.

Living in Sheffield, I feel we get very little value from the Council. I commute to CHCH for work each week day and the quality of the road along the Old West Coast Road has been appalling. I have lived here for three years, and it is a joke how many times the same parts of the roads get re-sealed. Clearly the sealant is low quality, as in a heavy rain, the pot holes return, and we are back to square one. The quality of the road closer to Sheffield is particularly bad.

Regarding the new provision of green waste collection, it does not extend to Sheffield. I asked about it, and was told no, it only goes as far as Darfield. So another example where we as a small community on the margins of the Council are ignored and left out.

Now you want to close the pool, and have signalled you may do the same with the Hall. That was not a suprise with this Council. In order to gain some positive thoughts from our community, you should gift both back to the Community, to a Trust or to the School, and allow us to maintain and use both facilities locally.

I went over a breakdown of my rating bill, and thought of how many of those costs are completely irrelevant to me. As I commute to CHCH, I don't ever go to Rolleston, and only go to Darfield once or twice per month, at the most, and then it is just to get petrol or groceries. Nothing else.

I tried the Library in Darfield, and it was dreadful. They have put a table tennis table into the library, and it was noisy and I got hit on the head twice by the ball. I was so annoyed I said to the librarian about it, and she said they were prioritising offering something to do for local school children. I said to her if you end up getting no one coming to the library you only have yourselves to blame. That building is big enough to house a table tennis table in another room. I have been to that library now four times, and that time was my last, and I will not be going again. Each time, the book selection was poor. Not one author I wanted was there, and very few books in the non-fiction categories were of interest. I then looked online at the catalogue, and saw that the entire Selwyn Library catalogue was of poor and limited quality.

Next complaint is about names. Please put English first. I am quite proficient in Māori but all New Zealanders, including immigrants, know English. Not many know Māori. I have done one trip to Rolleston in the three years I have lived here, and couldn't even find the new library, as it had a Māori name, and no English signage saying it was the library. I teach mainly Pasifika and immigrant students, and they are very positive about our indigenous culture and respectful of our language, but are barely coping with English, so to make things more complicated by prioritising Māori over English lacks common sense. I have no issue with Māori signage, but think the English should come first.

Next complaint is the water. Please stop whatever is in it! It tastes horrific. I have got to pay for bottled water, and I am saving up for a filter. Everyone I know out here has filters now installed. The plumbers must be happy! You did not consult if we wanted that. It is no longer required by the government, so please stop adding fluoride or chlorine, or whatever it is that tastes awful, smells awful, and makes everything go yellow. Out here at Sheffield our water was of a good quality before you added that stuff to our supply. You are not obliged to keep doing this, so please stop.

Final summary is I think you need to prioritise basic things first - the stuff councils are meant to provide: roads, water, sewerage, and rubbish collection. Then look at parks and facilities. However, be aware many ratepayers never use even those, so at that point, you need to survey your ratepayers as to what is actually a priority - you are elected representatives of the ratepayers. We are into a recession, and the nation has huge debt. This ten year plan should be about consolidation. Ensuring the basics are provided, but not a lot else. Aim for a more positive next ten year period, when hopefully the economy is stronger and more vibrant, and then the extras, like parks and facilities, can be expanded. Maybe work in with schools, like Papanui High School has with the Council with the Graham Condon Centre. Share the costs.

I have lived in five council areas in my adult life as a ratepayer, and this is certainly the worst experience I have had of a council: in the lack of what is provided just because I live in a more rural location within the council, and in the sense of ideals of the Council being prioritised over the basics, without consultation. In fact, it has been such a negative experience living out here regarding how the Council is, with the roads, the water, the lack of green waste collection, and now the pool closing, I am planning to sell when I can, to move. The main reason is just how badly we are treated

by the Council - it makes for a miserable existence out here. It really feels like the Council simply does not care. Rolleston then Lincoln are the priorities, and to a lesser extent, Darfield and Lesston, but the rural ratepayers are just almost irrelevant.

I am not normally a negative person, but truly, these three years out here, with one thing after another, it has been a very negative experience with the Council, without one positive aspect I can think of.







I am concerned that the council is falling behind on provisioning of infrastructure and services to the ever-growing population of Selwyn. The Lincoln town centre plan is considerably out of date and was written with a population of about 10,000 people in mind- which the recently approved subdivisions in the area will double in the near future. If it takes the council 10 years to even get projects started, then we should be seeing much more proposed for Lincoln in the current long-term plan, including a swimming pool and more playing fields and public recreation facilities. I don't see evidence of a clear plan for dealing with the increased traffic that comes with the growing population- especially the burden that will be placed on Prebbleton and the southern suburbs of Christchurch with twice as many cars traveling through their neighbourhoods. Nor is there a clear plan for making it safer for cyclists and pedestrians within our towns- we have excellent bike paths in some areas (for example, I commute via the rail trail from Christchurch through Prebbleton and to Lincoln), but the paths virtually disappear in the towns themselves where cars have priority over bikes. I know that the school my children go to has constant problems with traffic created by parents dropping kids off, and that feedback from parents has been that they don't feel the roads leading to the school are safe enough for their kids to ride bikes- thus leading to more traffic and even more unsafe conditions. DARK SKY

Castle Hill Village is located in the mountains and is void of any close town of city light-influence. It is an ideal location to view the stars and milky-way. However, a few years ago the street lights were changed from standard globes to LED. We request that the Castle Hill Village be designated a "Dark-Sky" zone with suitable street lighting to prevent light polluting residents' viewing of the night sky.

GREEN WASTE

The permanent residents of Castle Hill Village have no facility for the disposal of green-waste in the Village. With the Village becoming more "forested" with the planting of beech trees, and with existing beech trees getting larger, snow and heavy wind events often break branches off which need disposing of.

We request that a green-waste facility, possibly a dedicated open-top container, be located adjacent to the recycling/rubbish skips in the Village.

VILLAGE ENTRANCE

The Village entrance posts and railings are rotting and unsightly and need replacing.

It is requested that the Village entrance be rebuilt in keeping with the original design and theme.

WILDING SEED AGENT TREES

The Canterbury Regional Pest Management Plan designates Douglas fir and larch as pest conifers. Currently the Castle Hill Village reserves have a number of these wilding seed-source trees still growing there. These trees are spreading their seeds onto adjacent properties in breech of the RPMP.

We request that the remaining wilding seed-source pest trees on Castle Hill Reserves be removed immediately.



Clients are often referred to CAB from government organisations and our information is located on most government websites as a place where individuals can get reliable information.





2. Waihora Whata Rau - community facility and reserves upgrade Leeston

After consulting with the community, in the last Long-Term Plan we proposed a new community facility for Leeston, called Whata Rau, which would be built alongside the park, providing a 'hub' for Ellesmere where residents can gather, play, and learn.

2a. Whata Rau - new community facility

After consulting with Ellesmere residents during the last Long-Term Plan, we agreed to build a new library and community centre called Whata Rau, next to Leeston Park. This project would provide more community spaces that are needed in the area, and provide a solution for the existing Leeston library and service centre: the current facility is earthquake prone and needs significant repairs or to be replaced.

Increased construction costs and land remediation issues mean the costs to build Whata Rau have increased. Given this new information we want to hear from you - should we:


